SUPERVISORS VOTE \$3700 CONTRIBUTION TO SIREN/DEFIBRILLATOR FUNDS

At their Tuesday, Dec. 13th meeting the Board of Supervisors, at Gary Giacomini's request, approved the expenditure of \$3700 to match our contribution to the Siren and Defibrillator Funds.

In the Carter Collins Defibrillator Fund we have the following commitments: Carter Collins Memorial Fund at Bank of Marin: \$1200; MWPCA: \$1000; Marin County: \$1000, for a total of \$3200 to date.

In the Siren Fund we have MWPCA funds of \$2700; Marin County: \$2700 for a total of \$5400 to date.

The Marin Municipal Water District has replied: "...it is beyond the mandate of this District to participate in the capital funding of other agencies or associations without clear and direct benefit to MMWD."

GGNRA has contacted us and is committed to helping us in whatever way they can. According to J. R. Tomasavec, GGNRA has a "good neighbor" policy. He was going to see if a portion of the \$93,000 in Burton Funds can be allocated for GGNRA's contribution of \$3700 for the siren and defibrillator. He also gave us the name of persons who might be able to assist us with locating a used siren. To date we've not heard from the State Dept. of Parks and Recreation in response to our request.

All side streets must bring trash up to Panoramic Hwy. and placed in designated areas at the road's intersection with Panoramic. The exceptions are Mt. View Ave. and Ridge Ave/Lane. Ridge trash must be placed at area designated near MWPCA Clubhouse. No trash will be picked up at Ridge and Panoramic or Mt. View because there is inadequate room for a truck to stop safely. If you have any questions about where to put your trash please call M. V. Refuse at 457-9760.

Mill Valley Refuse is also cooperating with the Fire Department and our Association for debris removal during our cleanup days in May and August. They will provide debris box service at the MWPCA parking lot for branches that cannot be chipped.

THREE CHIPPER DAYS PLANNED FOR 1995

The first of three chipper days planned by MWPCA and the Marin County Fire Dept. will be held on Saturday, February 11. Branches must be brought to the MWPCA lower parking lot between 10 AM and 2 PM on Saturday.

Plans are being made for another chipper day in late May or early June. A third day will be planned for August. Because we can burn debris in early spring, we won't need debris boxes for unchippable stuff. M. V. Refuse will supply debris boxes for the May/June and August cleanup days. A \$5 donation will help offset the cost of debris boxes and chipper use.

FEBRUARY 11 & 12 ARE CLEANUP DAYS Bring your branches for chipping or burning and your body for working.

We need help cleaning and fixing the Community Building/Clubhouse, pulling broom, moving logs and branches prior to the understory burn being conducted by the Park Service and County Fire Dept. Work contributions will count for working membership discounts on Clubhouse rentals. We need helpers to clean out cupboards and closets and cabinets, clean windows, stack wood, organize kitchen utensils, straighten up stuff in the storage shed, make minor repairs on outdoor tables and benches, etc.

We'll start at 9 AM on each day and work until 5 PM. Please bring something for a potluck lunch. Beverages will be provided. For more information contact one of the following: Barney Lenheim at 383-1447; Stella Winn at 388-3394 or Del Goetz at 388-8493.

In conjuction with our Cleanup Days, residents will be permitted to bring brush and tree limbs for chipping and/or burning. Non-chippable branches, etc. will be stacked in the lower parking lot for burning at a later date (to be arranged by Marin County Fire Dept.).



EARTHQUAKE PREPAREDNESS MADE EASY

Did you know that there is a store in Albany specializing in the sale of 'state of the art' earthquake supplies? It's one-stop shopping --thanks to Darlene and Fred Jan owners of *The Earthquake Outlet* at 981 San Pablo Blvd. in Albany. They have done their homework and the shopping for you. The Jans, who both hold other jobs, sell at Price Club prices. They worry about us all being unprepared when the *big one* comes our way.

You will find everything from gas shut-off wrenches and water storage drums to a completely equipped garbage can full of supplies for a family of four. Darlene puts these together and just charges a small fee for the shopping time it requires. You will also find gadgets, brackets and fittings to earthquake-proof your house. Imagine, for example, your kitchen after a quake -- every cupboard and drawer will be open and all the contents on the floor. This can be prevented with some simple 'state of the art' fasteners developed in Japan (where they *know* earthquakes). Who's got 'em? You got it -- *The Earthquake Outlet*.

You will also find supply kits for your car, your office and your child's school locker. The Jans are 'in the know' when it comes to earthquake survival. If you can't make it to Albany, call them and they can FAX or mail lists of available supplies. You can order by phone and have items delivered via UPS to your door.

Now is the very best time to get prepared. If the *Big One* hits on a rainy night in January (as it did recently in Japan) the power, gas, water and phone are gone. The roads are out; the bridges down and we won't be able to get anywhere or get help to us for probably a week. What will you do? How will you live?

I urge you to check out the *The Earthquake Outlet* at 981 San Pablo Blvd. in Albany, CA 94706. Phone (510) 526-3589. Store hours are 9 AM to 5 PM Monday through Saturday.

FROM THE PRESIDENT

As we greet 1995, we must reflect a bit on what our Association achieved in 1994. The Mountain has considerably less fire fuel than previously. Thanks to Dave Boyd and the State Dept. of Parks & Recreation, we rid ourselves of 40 acres of broom and numerous exotics (Acacia & Eucalyptus) and our deer can graze on grass in the Park instead of in our yards. Thanks to our residents for joining in the cleanup, making our mountain considerably more fire-safe. Our Fire Station is still open. Our Mountain Emergency Team is organized and becoming ever better prepared to deal with a major disaster. Our AM Radio Station is up and running and we have a head start on our efforts to get a defibrillator for our Fire Dept. another siren up on Ridge.

1995 will witness an extension of this good work. On January 21 we will have the first of several CPR classes for residents. Later this Spring, we'll have a half-day program to update MET disaster skills and train new volunteers for the Mountain Emergency Team. We've arranged for 3 Chipper Days to help clean up brush and debris and thus reduce our fire hazard. Dave Boyd has his crews out cutting broom and trees in preparation for Phase II of the Grasslands Restoration Project — a controlled burn between Four Corners and the Tourist Club, above the Sun Trail up to Ridge Ave. and MWPCA property. Our Panoramic Firebreak is beginning to materialize and the County and GGNRA have committed to help us with the Siren/Defibrillator project.

We have accomplished a great deal. But perhaps the most important thing we accomplished in 1994 was getting people to meet and talk with one another about issues that affect us all. If a wildfire or the big one does hit, our life may well rest in the hands of our neighbors. So let us continue reaching out to our neighbors. Make an effort to get to know everyone whose property touches yours. Make sure you have their contact phone numbers and learn a little about them and their property. If you need help with your outreach, call me at 388-8493 so I can arrange help.

Have a happy, healthy and productive 1995.




