Throckmorton Ridge Fire Station News

Has anyone been wondering what all the chainsaw noise has been all along Panoramic? Fire Safe Marin has been awarded a grant from the USFS for \$282,000 to create a fuel break along Panoramic Highway.



The project starts at Four Corners and continues past the fire station. It is approximately 2 miles of fuel break. The Marin County Fire Department's Tamalpais Fire Crew and a private contractor have been working long hours to accomplish this task. The project is overseen by Marin County Fire Forester, Kent Julin, who was able to coordinate efforts from private citizens and the State Parks to allow crews to clear vegetation from these areas. Now that winter is here what should you do to prepare for the onslaught of winter storms soon to arrive?

1. Prepare your family. Make sure you have enough food, water and medicine for 5-7 days.
2. Have your address clearly marked on your residence with 4-inch reflective contrasting lettering.
3. Clean your chimney before using.
4. Do not block the roadways. 12 feet of clearance is required on all roadways. Please do not block the access of emergency vehicles to your residence or to your neighbors'.
5. Contact PG&E regarding tree limbs that may come in contact with power lines.
6. Assume that all power lines are energized and can kill you.

On October 22nd the Marin County Fire Department and the Marin County Sheriff's office conducted an evacuation drill of the Throckmorton Ridge area. At 9AM approximately 100 residences were contacted through the Office of Emergency Services TENS phone system asking the citizens to participate in a live evacuation drill. The emergency siren

was activated and emergency workers began to go door to door evacuating citizens. The MMWD began the evacuation of the watershed and the CHP simulated road closures and helped to ensure the safety of pedestrians on the roadway.

The disaster council in coordination with CERT volunteers, the Red Cross and the Human Society set up an evacuation shelter at the Muir Woods Park Community Center. At the community center 58 residents were checked in as well as numerous animals. The purpose of the drill was to bring awareness of the wild land interface hazards that exists in our community and to test the multi-agency coordination which will be required of an incident of this magnitude. Drills like this in conjunction with homeowners' vegetation clearance, manmade fuel breaks and community awareness will be necessary to limit the loss of life and property in the event of a major wild land fire.

We would like to thank all of the residents and volunteers who participated in the evacuation drill. It was a huge success and we look forward to more in the future. If anyone is interested in becoming a member of the Disaster Council or CERT please contact the Throckmorton Ridge Fire Station.

Disaster Council Report

The MWPCA Clubhouse was the hub of activity during the October 22nd Disaster drill. Fire Engines, fire trucks, ambulances, highway patrol cars, sheriffs cars, Red Cross vehicles and a Humane Society van filled the upper and lower parking lots. Tents and tables for responders lined the path to the clubhouse door. Inside, stretchers and cots were set up to receive 'injured' evacuees.

Signs posted along Panoramic directed evacuees to the MWPCA Red Cross Evacuation center. After receiving the TENS phone call to evacuate and hearing the siren, residents of Upper Edgewood, Marin View, Annie Lane, Mountain View, Hamilton, Washington Park, Mountain Lane Trail, and the upper end of Panoramic, made their way on foot (some on bicycles) to the center. CERT trained volunteers helped to monitor the movement of evacuees and assisted the emergency responder professionals. Once evacuees reached the clubhouse, they checked in. They were then allowed to leave. In a real emergency they would have received further instructions as to what to do next.

The drill ended with a review / critique by all the personnel of the participating agencies. The opinion voiced by all was that it was one of the most successful drills that has been conducted by the Southern Marin emergency response agencies.

One of the tasks of the Disaster Council is to assess and evaluate its effectiveness; then use the data to adjust the Throckmorton Ridge Emergency Response plan to fit our particular needs. At the last meeting of the Disaster Council, Fire Captain Jeremy Pierce was pleased to report the high level of participation by residents. Fifty-eight evacuees came to the center. The Neighborhood Liaisons reported in with their damage control reports. The Humane Society reported that two dogs self-checked themselves in. Later their owners were found and the dogs were returned to their homes.

The success of the day does not mark the end of the preparation plans that are so important to the safety of our mountain community. During this past month, neighborhood liaisons have been contacting neighbors and gathering information. To be prepared it is necessary to know the names, addresses, contact information, and special needs of all who live on the mountain. It is especially important for neighbors to help each other. Residents who cannot easily evacuate on their own need to be identified and plans made to assist them. If you have received your 'green' form please fill it out and return it to your street liaison.

At the foot of the Ocean View Trail you can walk among the giant redwoods on our new boardwalk. Bootjack Trail, now under complete renovation thanks to youth-power!, will be done at the end of January. And, a totally new landscape awaits you (and salmon!) at Muir Beach with the complete recontouring of the floodplain to allow the historic channel to once again flow. Backwater channels offer refugia to fish, wetlands will again welcome waterfowl and the new pedestrian bridge allows the creek to flood more naturally (and places of little impact to the community!).

Visitors observe more and more wildlife. Coyotes prowl and hunt. Foxes are once again a common sighting. The otter family makes regular appearances throughout Redwood Creek. Have you seen the new store "GROW" at Tam Junction?

A few weeks ago between raindrops GROW hosted a well-attended open house that I participated in. On hand were: a Mexican food truck, educational materials, live chickens and coops, dogs, live bees and bee hives, raised bed demonstration gardens, organic local veggies, fruits and oysters, and on-tap beer and wine.

Our neighbor owners Kelly Scott and Martha Pearl of Alpha Dog (dog boarding) and Will Hutchinson and Nate McCarthy of Proof Lab, created this sustainability-themed art and garden center located in the lot adjacent to their other businesses. (Nate lives on Panoramic.)

At the geographic crossroads of Tam Junction, the vision is to provide an educational, fun and environmentally friendly (green) resource center for locally grown organic food, gardening and permaculture, art and ceramics classes, a children's art studio, environmental education and outreach focused on sustainability.

I tabled with Dr. Pincetich from the local non-profit organization Turtle Island Restoration Network, www.tirn.net, working to save sea turtles internationally. During the BP Deepwater Horizon spill 2010 they helped protect and rescue four species of endangered turtles (Kemp's ridley, green, loggerhead and hawksbill sea turtles) and a fifth threatened specie, the leatherback.

At GROW there are permaculture classes, a vegetable garden art and ceramics and a children's art studio. I saw some of my neighbors there. On Fridays and Saturdays you can buy fresh, gorgeous produce from Marin Organic, and locally grown vegetable starts and native plants from Root for Peace, www.RootforPeace.org. Some sales proceeds will go to end hunger in East Africa. GROW is talking about having a film program, too.

The folks at GROW are working on solutions such as: growing and buying local food like veggies, fruits and chicken eggs, using solar and renewable energy, habitat restoration, and using permaculture and sustainability principles.

Supporting our local business can be a win, win for all of us. Helping to make this vision come about and spread these ideas and creativity is an exciting solution-based response to challenges.

These folks are beginning to be the change themselves, and we can be part of that change. Ride the West Marin Stagecoach down to GROW; it stops right there at Tam Junction.

Information or Action?

On September 15, 2011, County Supervisor Steven Kinsey facilitated another public health discussion at the Muir Woods Park Community Association Clubhouse. His opening remarks reminded us that this discussion has been going on for many years. Three years ago, a group of residents formed a Sewer Committee and partnered with the County to pay for a preliminary study of what a sewer district would look like up here on the mountain. Early in 2011, that committee proposed that the community hold an election to form a proposed Sewer District. Some residents still felt this initiative was being taken too early. So this meeting was set up to provide more information and continue the discussion.

The first presenter was Rebecca Ng, Chief of Marin County Department of Environmental Health Services. She reminded us that the State of California is the legal authority in this area of governance—it makes the rules and delegates at least some of the supervision to the County's Department of Environmental Health Services.

The State of California is about to issue new regulations for septic systems: AB885. The rewrite was inspired by the State's intervention in Malibu, where there were serious public health problems due to poor septic system maintenance. AB885 is being commented on right now, and is expected to go into effect in 2013.

The County anticipates new septic system regulations that will raise the standards, be quite specific, and be somewhat cumbersome in its enforcement. Ms. Ng assured us, however, that the County would remain as reasonable and supportive of our needs as possible.

The second presenter was Deitrich Stroeh, the consulting engineer contracted by the Sewer Committee & County. First he pointed out that he has personally assessed more than 10% of the homes in this community, and has found all of them out of compliance with County requirements.

Then Stroeh reported on the survey concerning those who would like to "opt out" of participation in any Sewer District or Sewer Assessment District.

The Results:

Lots with housing units: 280

Opting Out: 87

Units remaining to vote on formation of Districts: 193

(Failure to respond was counted as "remaining to vote")

Though the committee believes the majority of those remaining to vote are in support of forming a sewer district, the alarm and discontent expressed by some of our residents causes the Sewer Committee to pause. Once again it asks, "Is there a more immediate and affordable way of dealing with our public health problem?"

Neighbor Gordon Robinson was our last presenter. He introduced himself as a "sewer agnostic" and part of a "loyal opposition" to the initiative taken by the Sewer Committee. He called for fence mending, and he made a plea for greater

civility and diligence in the discussion of options. He announced a new organization called the Environmental Health Committee. Its intent is to be a central point of contact for information, education, and support in dealing with septic system problems. Its web site is info@MWPSforum.org.

As a member of the Sewer Committee, I was pleased with the quality of information and the attitude presented by our County officials. But I fear that the outcry for "more information" is simply delaying responsible action. We've been "thinking" about this for twenty years.

The cost of corrective action is the core issue. Soil conditions in our community often require advanced septic systems, the expense of which is far greater than the simple trench-and-leach-line systems on which many of us currently depend. Addressing the problem together through a sewer system would probably be the solution most affordable for everyone.

Ultimately, the cost of corrective action cannot be avoided. At the time of sale, the cost of a non-compliant septic system is deducted from the value of our property. If the government intervenes it will do so by immediately "borrowing" against the value of our property. A Sewer District is also a system by which we "borrow" against the combined value of all our properties. By contrast, the public health issue continues to diminish the value of the neighborhood as a whole.

Both sewers and septic systems are getting more technologically sophisticated. But the costs of either solution are not coming down. The sooner we act, the better.
