# How To Vote! Community Meeting with Rodoni & DPW

This special edition of the Lookout is dedicated to the voting guidelines in the County of Marin for the 2020 Election on November 3 and to announce an upcoming Zoom Town Hall Meeting for our neighborhood with Supervisor Dennis Rodoni.

The State and County have made several changes in regards to voting that we all need to be aware of and share with our neighbors:

- IMPORTANT: The MWPCA Clubhouse WILL NOT be a polling place for this election.
- Due to challenges in safely staffing polling locations, the County is decreasing polling locations from 90 to 30 this year. When you receive your State mandated mail-in ballot beginning October 5, our new consolidated polling place will be printed on the back. You don't need to go to the polling place should you wish to mail in your ballot, but you may.
- Polling locations will be open for four days, October 31-November 3.
- In addition to official polling locations, the County is placing secure Ballot Boxes in various spots.
