A Big Thank You to Our Highway Department for a Job Well Done This Winter

This past winter was one for the books, and despite the heavy snowfall and challenging conditions, the Town of Lincoln's Highway Department rose to the occasion—once again proving their dedication, resilience, and efficiency.

With a small but mighty crew, our Highway Department completed an impressive 120 plow runs during the 2024/25 winter season. For perspective, that's more than double the 56 runs in 2023/24 and significantly more than 72 runs in 2022/23 and 65 in 2021/22. Even with limited manpower, our team worked tirelessly to ensure that our roads remained safe, clear, and passable for residents, emergency services, and school buses alike.

We also want to extend a heartfelt thank you to the City of Oneida DPW, whose partnership helped us weather another challenge this season—a regional salt shortage. By supplying us with road salt during a critical time, they not only helped us maintain our high safety standards but also saved our town the cost and burden of sourcing salt from outside our area. It's this kind of collaboration that strengthens our entire region.

To our Highway crew—your hard work doesn't go unnoticed. Thank you for your commitment to keeping Lincoln moving, no matter what the forecast throws our way!


Signing up is quick and easy—and it ensures you won't miss out on timely notifications that could impact your daily routine.

Madison County Solid Waste and Recycling Goals for 2025: A Greener, Smarter Future



Madison County is taking bold steps in 2025 to build a more sustainable, efficient, and environmentally responsible future through a series of clearly defined Solid Waste and Recycling Management Goals. These goals align with New York State Department of Environmental Conservation (DEC) priorities and climate action legislation.

Here's what residents can expect:

1. Boosting Organic Waste Reduction & Composting

The County is expanding composting opportunities at the Buyea Road Transfer Station, aiming to divert more organic materials from landfills. This includes new partnerships with local farms, schools, and businesses and greater public education efforts on composting benefits. A state grant application is in process to help support this growth.

2. Reducing Greenhouse Gas Emissions from Landfills

Through improved landfill gas management and methane capture, including "caisson wells" and new dewatering systems, the County is working hard to minimize the environmental impact of waste disposal. These initiatives support New York's goals for climate change

3. Increasing Recycling Participation & Reducing Contamination



An expanded public education campaign is underway to teach proper recycling methods, aiming to boost participation and reduce contamination. The County plans to hold workshops and work with communities to improve recycling collection infrastructure. This goal also ties into upcoming contract discussions for waste collection services.

4. Promoting Extended Producer Responsibility (EPR) Programs

Madison County is advocating for and supporting state legislation that requires manufacturers to take responsibility for the full life cycle of products like electronics. Locally, efforts are underway to create convenient drop-off sites and build partnerships with businesses for collection programs.

5. Partnering Regionally for Waste Diversion & Landfill Efficiency

Looking toward collaboration, the County is exploring partnerships with neighboring communities to share landfill capacity and promote sustainable waste practices. Plans include designing a joint waste diversion program, tracking waste diversion progress, and pursuing grant opportunities for sustainable infrastructure projects.


Looking Ahead

Have you ever seen a notice for a "public hearing" and wondered what it means or how to get involved? Public hearings are an essential part of local government—and they're one of the most direct ways residents can have a say in the decisions that affect their community.

What Is a Public Hearing?

A public hearing is a formal meeting where officials invite the public to provide input on specific issues before a decision is made. Topics can include zoning changes, local laws, budgets, development projects, environmental concerns, and more. Public hearings ensure transparency and give community members an opportunity to share their thoughts, concerns, or support.

How to Get Involved:

- 1. Stay Informed: Watch for public hearing notices on the town website, social media, or posted at the Town Hall.
- 2. Attend the Hearing: Hearings are open to all residents. You can attend in person and, in some cases, virtually.
- 3. Speak Up: If you wish to comment, you'll usually be given a few minutes to speak. Be respectful, stay on topic, and clearly state your position.
- 4. Submit Written Comments: If you can't attend, you can often submit your thoughts in writing before the hearing. These are reviewed just like in-person comments.

Why It Matters:

Your voice helps shape your community. Whether you're concerned about a new development, interested in environmental issues, or want to support a local project, participating in public hearings is a powerful way to make an impact.

Your opinion counts—be informed, be involved, and help guide the future of our town.
