## TOWN OF LINCOLN 6886 Tuttle Road Canastota, NY 13032 Town Board Budget Meeting

Wednesday October 23, 2024

Call to Order: 6:01pm

**Attendance**: Supervisor Melissa During, Peggy LeClair, Doug Fusillo, Doug Holdridge, and Jayne Black.

*Others in Attendance:* Amanda Spendley, Mat Spendley, Anthony Domenicone, Mike (GLAS) and Madison County Chairman Jim Cunningham.

Madison County Chairman Jim Cunningham came to the meeting to discuss the possibility of the Town of Lincoln taking over the Clockville Water district. Because the county is in the process of changing from a BAN (Bond Anticipation Note) to a BOND they decided to reach out to the town before hand and share some benefits of the Town taking over the district. Jim Cunningham stated the water district is self-funded and there would be no monetary change it would just be the ownership and the availability to grow the district without consulting with the County. This would roughly take a year to switch over due to having to correspond with the Town of Lenox as part of the district is in their town. Doug Fusillo asked what happens if OCWA decides they do not want to continue providing service for this district. Jim Cunningham stated they would probably not decide that as they would like to grow. Doug Fusillo stated he would like to see the agreement as this was not a district the town wanted in the first place as it was voted down. Melissa During also shared her concern about a letter that was just received stating the OCWA bill go up 118% for residents that are not in Onondaga County. The board decided to discuss this at the next Town Board meeting.

Mike form GLAS joined and explained the Ambulance company now gets paid direct from the insurance companies. Their call volume has increased in the past year. They are at a \$7,000 deficit for their budget that will get split between the Town of Lincoln and Town of Lenox. Real Property will calculate the amounts to be charged from each town. Doug Holdridge asked if GLAS has figured out the call ration from the Town of Lenox vs the Town of Lincoln. Mike is to get those numbers for Doug.
