Report on the Audit of the Financial Statements

Opinions

We have audited the accompanying financial statements of the governmental activities, the business-type activities and each major fund of the City of Corydon, Kentucky, as of and for the year ended June 30, 2024, and the related notes to the financial statements, which collectively comprise the City of Corydon, Kentucky's basic financial statements as listed in the table of contents.

In our opinion, based on our audit, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, the business-type activities and each major fund of the City of Corydon, Kentucky as of June 30, 2024, and the respective changes in financial position, and, where applicable, cash flows thereof, for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinions

We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the City of Corydon, Kentucky and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

Emphasis of a Matter

As discussed in Note 15 to the financial statements, the 2023 financial statements have been restated to correct a misstatement. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the City of Corydon, Kentucky's ability to continue as a going concern for twelve months beyond the financial statement date, including any currently known information that may raise substantial doubt shortly thereafter.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinions. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing

standards and *Government Auditing Standards* will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards and *Government Auditing Standards*, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the City of Corydon, Kentucky's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the City of Corydon, Kentucky's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the budgetary comparison information on pages 26 and 27 be presented to supplement the basic financial statements. Such information is the responsibility of management and, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquires of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Management has omitted the management's discussion and analysis that accounting principles generally accepted in the United States of America require to be presented to supplement the basic financial statements. Such missing information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who consider it an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. Our opinion on the financial statements is not affected by this missing information.

Other Reporting Required by Government Auditing Standards

In accordance with *Government Auditing Standards*, we have also issued our report dated December 19, 2024 on our consideration of the City of Corydon, Kentucky's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the City of Corydon, Kentucky's internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering City of 's internal control over financial reporting and compliance.

NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The City of Corydon, Kentucky is a municipal corporation formed in 1847 operating under a Mayor/Council form of government and provides the following services as authorized: fire protection, parks and recreation, public works, and general administrative services. The City of Corydon also owns and operates a sewer system.

The accounting and reporting policies of the City relating to the funds included in the accompanying basic financial statements conform to accounting principles generally accepted in the United States of America applicable to state and local governments. Generally accepted accounting principles for local governments include those principles prescribed by the Governmental Accounting Standards Board (GASB), the American Institute of Certified Public Accounts in the publication entitled *Audits of State and Local Governmental Units*, when applicable. The City follows GASB pronouncements as codified under GASB No. 62. The more significant policies of the City are described below:

a) Financial Reporting Entity

The City of Corydon, Kentucky (primary government) is a municipal corporation governed by an elected mayor and four-member council. The City adheres to the standards set forth in GASB Statement No. 14 as amended by GASB Statement No. 61 in reporting the primary government. The City of Corydon, Kentucky has no component units.

b) Basic Financial Statements-Government-wide Financial Statements

The City of Corydon's basic financial statements consist of both government-wide (reporting the City as a whole) and fund financial statements categorize primary activities as either governmental or business-type. The City's fire protection, parks and recreation, public works, and general administrative services are classified as governmental activities. The City's sewer system is classified as a business-type activity.

In the government wide Statement of Net Position, both the governmental and business-type activities columns (a) are presented on a consolidated basis by column, (b) and are reported on a full accrual, economic resource basis, which recognizes all long-term assets and receivables as well as long-term debt and obligations.

The government-wide Statement of Activities reports both the gross and the net cost of each of the City's functions and business-type activities. The functions are also supported by general government revenues. The Statement of Activities reduces gross expenses by related program revenues, operating and capital grants. Program revenues must be directly associated with the function or a business-type activity. Operating grants include operating specific and discretionary grants while the capital grants column reports capital-specific grants.

The net costs (by function or business-type activity) are normally covered by general revenue (property and insurance taxes, franchise fees, intergovernmental revenues, interest income, etc.)

The City does not allocate indirect costs. Except for the charges from the City's enterprise fund to various other functions of the City and transfers between the City's enterprise fund and its governmental funds, all interfund activity has been eliminated.

The government-wide focus is more on the sustainability of the City as an entity and the change in the City's net position resulting from the current year's activities.

c) Basic Financial Statements-Fund Financial Statements

A fund is an independent fiscal and accounting entity with a self-balancing set of accounts. Fund accounting segregates funds according to their intended purpose and is used to aid management in demonstrating compliance with finance-related legal and contractual provisions. The minimum number of funds maintained is consistent with legal and managerial requirements. The financial transactions of the City are reported in individual funds in the fund financial statements. Each fund is accounted for by providing a separate set of self-balancing accounts that comprises its assets, liabilities, fund equity, revenues and expenditures/expenses.

The emphasis in fund financial statements is on the major funds in either the governmental or business-type activities categories. Nonmajor funds by category are summarized into a single column. GASB No. 34 sets forth minimum criteria (percentage of assets, liabilities, revenues or expenditures/expenses of either fund category or the governmental and enterprise combined) for the determination of major funds. The City electively added funds, which either had outstanding debt or specific community focus.

d) Governmental Funds

The focus of the governmental fund's measurement (in the fund statements) is upon determination of financial position and changes in financial position (sources, uses, and balances of financial resources) rather than upon net income. The City reports these major governmental fund and fund types:

General Fund:

The General Fund is the City's primary operating fund. It is used to account for and report all financial resources except those required to be accounted for in another fund.

MRA Fund:

The Municipal Road Aid (MRA) Fund is used to account for the City's intergovernmental road aid funds that are legally restricted to expenditures for road and street maintenance.

The activities reported in these funds are reported as governmental activities in the government-wide financial statements.

e) Proprietary Funds

The focus of proprietary funds measure is upon the determination of operating income, changes in net position, financial position, and cash flows. The generally accepted accounting principles applicable are similar to those used by businesses in the private sector.

Enterprise Fund:

Enterprise Funds are required to be used to account for operations for which a fee is charged to external users for goods or services and the activity is financed with debt that is solely secured by the pledge of the net revenues. The activities reported in these funds are reported as business-type activities in the government-wide financial statements. The Enterprise Fund of the City, which primarily serves the City residents is comprised of sewer operations.

f) Measurement Focus - Basis of Accounting

Measurement focus refers to what is being measured; basis of accounting refers to when revenues and expenditures are recognized in the accounts and reported in the financial statements. Basis of accounting relates to the timing of the measurement made, regardless of the focus applied.

Governmental funds (General and MRA fund) financial statements are reported using the current financial resource focus and are accounted for using the modified accrual basis of accounting. Under the modified accrual basis of accounting, revenues are recognized when susceptible to accrual; that is, when they become both measurable and available. "Measurable" means when the amount of the transaction can be determined and "available" means collectible with the current period or soon enough thereafter to be used to pay the liabilities of the current period. The City considers property taxes available if they are collected within 60 days of year end. Insurance taxes are reported as revenue when received. Intergovernmental revenues received for specific purposes or projects are recognized based upon expenditures recorded. Expenditures are recorded when incurred.

The government-wide statements and fund financial statements for proprietary funds are reported using the economic resources measurement focus and the accrual basis of accounting. The economic resources measurement focus means all assets and all liabilities (whether current or non-current) are included on the statement of net position. Under the accrual basis of accounting, revenues are recognized when earned, including unbilled sewer which is accrued. Expenses are recognized at the time the liability is incurred.

g) Revenues - Exchange and Non-Exchange Transactions

Revenue resulting from exchange transactions, in which each party gives equal value, is recorded on the accrual basis when the exchange takes place. On a modified accrual basis, revenue is recorded when the resources are available and measurable. Available means that the resources will be collected within the current fiscal year or are expected to be collected shortly thereafter to be used to pay liabilities of the current fiscal year.

Non-exchange transactions, in which the City of Corydon receives value without directly giving equal value in return, includes insurance and property taxes, grants, entitlements, and donations. Revenue from grants is recognized in the year in which all of the eligibility requirements have been satisfied. Eligibility requirements include timing requirements, which specify the year when the resources are to be used or the year in which use of the funds is first permitted, matching requirements, in which the City of Corydon must provide local resources for a specified purpose, and expenditure requirements, in which resources are provided to the City of Corydon on a reimbursement basis. On a modified accrual basis, revenues from non-exchange transactions must also be available before it can be recognized.

h) Cash Equivalents and Investments

Cash equivalents include demand deposits as well as all highly liquid investments with a maturity date of three months or less when purchased by the City of Corydon. Money market and certificate of deposits are stated at amortized costs which approximates fair value. Kentucky Revised Statute No. 66.480 allows the City to invest in U.S. Government and Agency securities.

i) Receivables

All receivables are reported net of estimated uncollectible amounts. Sewer fund accounts receivable consist of both billed and unbilled sewer services.

j) Capital Assets

Capital assets purchased or acquired with an original cost of \$1,000 or more are reported at historical cost or estimated historical costs. Contributed assets are reported at fair market value as of the date received. Additions, improvements and other capital outlays that significantly extend the useful life of an asset are capitalized. Other costs incurred for repairs and maintenance are expensed as incurred. The City reports major general infrastructure assets constructed or acquired in fiscal years ending after June 30, 2002, or that received major renovations, restorations, or improvements during that period. Depreciation on all assets is provided on the straight-line basis using the following estimated useful lives:

Buildings	40 years
System improvements	25-50 years
Equipment	3-15 years
Vehicles	5 years

k) Long-Term Debt and Bond Costs

In the government-wide and proprietary financial statements, outstanding debt is reported as liabilities. Bond issuance costs are expensed as incurred. Bond premiums and discounts are amortized over the life of the bonds issued.

The governmental fund financial statements recognize the proceeds of debt and premiums as other financing sources of the current period. Issuance costs are reported as expenditures.

l) Property Tax Calendar and Revenues

The City is responsible for levying and collecting property taxes. Property taxes are levied on October 1st based on assessed property value as of January 1st, and are due and payable at that time. Property taxes become delinquent December 31st of the same year. Taxes are considered delinquent 90 days after the due date. Property taxes are recognized as revenue to the extent they are both available and measurable and available; an appropriate allowance is established for those amounts deemed to be uncollectible.

m) Compensated Absences

The City does not accrue compensated absences as the amount is deemed immaterial by management.

n) Operating Revenues and Expenses

The City's proprietary funds distinguish between operating and nonoperating revenues and expenses. Operating revenues and expenses of the City's sewer operations consist of charges for services and the costs of providing those services, including depreciation and excluding interest costs. All other revenues and expenses are reported as nonoperating.

o) Net Position/Fund Balance

Net position represents the difference between assets and deferred outflows of resources, and liabilities and deferred inflows of resources and is classified into the following components:

- Net investment in capital assets - Capital assets, net of related accumulated depreciation and reduced by the outstanding balance of any related indebtedness that is attributable to the acquisition, construction, or improvements of those assets, net of unspent financing proceeds.
- Restricted net position - Net position with constraints placed on their use that are either externally imposed by creditors, grantors, contributors, laws, or regulations of other governments; or imposed by law through constitutional provisions or enabling legislation.
- Unrestricted net position - All other net position that does not meet the definition of restricted or net investment in capital assets.

In order to calculate the amounts to report as restricted net position and unrestricted net position, a flow assumption must be made about the order in which the resources are considered to be applied. It is the City's policy to consider restricted net position to have been depleted before unrestricted net position is applied.

In government fund financial statements, equity is classified as fund balance and is displayed in up to five components based primarily on the extent to which the City is bound to observe constraints imposed on the use of fund resources. These components are as follows:

- Non-spendable fund balance - Amounts that are not spendable, such as inventory or prepaid items, or required to remain intact.
- Restricted fund balance - Amounts constrained to specific purposes by their providers such as grantors, bondholders, and higher levels of government.
- Committed fund balance - Amounts constrained to specific purposes by the City itself, using its highest level of decision-making authority. To be reported as committed, amounts cannot be used for any other purpose unless the City takes the same highest level action to remove or change the constraint.
- Assigned fund balance - Amounts the City intends to use for a specific purpose. Intent can be expressed by the City or by an official or body to which the City delegates the authority.
- Unassigned fund balance - Amounts that are available for any purpose. Positive amounts are reported only in the general fund.

In order to calculate the amounts to report as restricted, committed, assigned, and unassigned fund balance in the governmental fund financial statements a flow assumption must be made about the order in which the resources are considered applied. It is the City's policy to consider restricted fund balance to have been depleted before using any of the components of unrestricted fund balance. Further when the components of unrestricted fund balance can be used for the same purpose, committed fund balance is depleted first, followed by assigned fund balance. Unassigned fund balance is applied last.

p) Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenditures during the reporting period. Actual results could differ from those estimates.

q) Deferred Outflows of Resources/Deferred Inflows of Resources

Deferred Outflows of Resources

In addition to assets, the statement of net position will sometimes report a separate section for deferred inflows of resources. This separate financial statement element represents a consumption of net position that applies to future periods; therefore, the item will not be recognized as an outflow (expenditure) of resources until that time. The City has no items that are required to be reported in this category as of June 30, 2024.

Deferred Inflows of Resources

In addition to liabilities, the statement of net position will sometimes report a separate section for deferred inflows of resources. This separate financial statement element represents an acquisition of net position that applies to a future period; therefore, will not be recognized as an inflow of resources (revenue) until that time. The City has no items that are required to be reported in this category as of June 30, 2024.

r) Interfund Activity

Interfund activity is reported as either loans, reimbursements or transfers. Loans are reported as inter-fund receivables and payables as appropriate and are subject to elimination upon consolidation. Reimbursements are when one fund incurs a cost, charges the appropriate benefitting fund and reduces its related cost as a reimbursement. All other interfund transactions are treated as transfers. Transfers between governmental and proprietary funds are netted as part of the reconciliation to the government-wide financial statements.

s) Budget and Budgetary Accounting

The City follows the procedures established pursuant to Section 91A.030 of the Kentucky Revised Statutes in establishing the budgetary data reflected in the financial statements. Budgets are prepared for all funds. The City of Corydon follows these procedures in establishing the budgetary data reflected in the financial statements:

1. Prior to June 1st, the Mayor obtains estimates in order to prepare the proposed operating budget.
2. Prior to June 30th, the Mayor submits to the City Council a proposed operating budget for the fiscal year commencing the following July 1st. The operating budget includes proposed expenditures and the means of financing them.
3. Prior to July 1st, the budget is enacted through the issuance of an ordinance approved by the City Council.
4. The Mayor is authorized to transfer budgeted amounts of any fund; however, any revisions that alter the total expenditures of any fund must be approved by the City Council. Therefore, the level of control on budgetary items is maintained at the operations level.
5. Formal budgetary integration is employed as a management control device during the year for the General Fund.
6. The budget for the General Fund is adopted on a basis consistent with generally accepted accounting principles (GAAP).

t) Adoption of New Accounting Policy

During the year ended June 30, 2024, the City of Corydon, Kentucky adopted GASB No. 100 Accounting Changes and Error Corrections. The primary objective of this statement is to enhance accounting and financial reporting requirements for accounting changes and error corrections.

NOTE 2 - DEPOSITS AND INVESTMENTS:

A) Deposits

All deposits of the City of Corydon are held at area financial institutions. As of June 30, 2024, the bank balances of the City of Corydon, Kentucky's deposits were \$505,442. The entire amount on deposit was insured or properly collateralized. A summary of cash and investments is presented below:

B) Investments

Interest Rate Risk

Interest rate risk is the risk that changes in interest rates will adversely affect the fair value of an investment. Investments held for longer periods are subject to increased risk of adverse interest rate changes. The City does not have a formal investment policy that limits investment maturities as a means of managing its exposure to fair value losses arising from increase interest rates.

Credit Risk and Custodial Credit Risk

Credit risk is the risk that an issuer or other counterparty to an investment will not fulfill its obligations. The custodial credit risk for investments is the risk that a government will not be able to recover the value of the investment or collateral securities that are in the possession of an outside party if the counterparty to the transaction fails.

Concentration of Credit Risk

Concentration of credit risk is the risk of loss attributed to the magnitude of the City's investment in a single issuer. The City does not place any limit on the amount that may be invested with one issuer.

NOTE 3 – ALLOWANCE FOR UNCOLLECTIBLE ACCOUNTS:

The sewer system allowance for uncollectible accounts receivable as of June 30, 2024 was \$2,961. The general fund allowance for uncollectible accounts as of June 30, 2024 was \$5,526.

NOTE 5 - PROPERTY TAXES:

Property taxes attach as an enforceable lien on property as of January 1st each year. Taxes are levied on January 1st of each year and are payable any time before October 31st of that year. Uncollected taxes at June 30th of each year are recorded as a receivable and the portion not collected within 60 days are recorded as unavailable revenue/deferred inflows of resources. Uncollected delinquent taxes are written off after one year. The City bills and collects its own property taxes. The City elects to use the assessment prepared by the Henderson County Property Valuation Assessor as its base to apply the property tax rate. Enforceable liens on delinquent property tax bills attach to the property when filed by the City on August 31st of each year. City tax revenues are recognized when levied to the extent that they result in current receivables.

The City is permitted by Section 157 of the Constitution of Kentucky to levy taxes of up to \$0.75 per \$100 of assessed valuation for general government services other than school purposes. The tax rate on real property to finance general government services other than school purposes for the year ended June 30, 2024 was \$.092 per \$100, which means that the City has a tax margin of \$.658 per \$100. Although this tax margin would indicate significantly higher potential tax revenues, the City is subject to an absolute maximum tax rate in that House Bill 44 prohibits levying a tax rate that will produce more revenue, exclusive of revenue from net assessment growth, than would be produced by application of the tax rate that was levied in the preceding year to the preceding year's assessment. The effect of this legislation has been to limit increases in property tax revenues to minimal levels.

Interest expense in the enterprise fund for the year ended June 30, 2024, was \$17,129 and is included on the statement of activities under business-type activities as direct function expenses. The City is exposed various risks of loss related to torts; theft of, damage to, and destruction of assets; errors and omissions; injuries to employees; and natural disasters. The City purchases commercial insurance for all risks of loss. Settled claims have not exceeded this commercial coverage in any of the past three fiscal years.

NOTE 8- OTHER EMPLOYEE BENEFITS

Compensated absences

All employees of the City earn and accrue vacation and sick time. No liability is reported for unpaid accumulated sick leave as it is non-vesting. Compensated absences obligations arise from amounts due City employees for amounts of vacation which will be available in the future, and are accounted for by the City in accordance with GASB No. 16 *Accounting for Compensated Absences*. As of June 30, 2024, no accrual for compensated absences was made as the amount is considered by management to be immaterial.

NOTE 9- COMMITMENTS AND CONTINGENCIES

In the normal course of operations, the City receives grant funds from various state and local agencies. The grant programs are subject to audit by agents of the granting authorities the purpose of which is to ensure compliance with conditions precedent to the granting of funds. Any liability for reimbursement which may arise as the result of potential audits is not considered to be material to the financial statements.

A portion of the governmental activities net position and fund balance in the amount of \$67,241 is restricted by statute for highway and road improvements.

A portion of the business-type activities net position and fund balance in the amount of \$25,322 is restricted by bond covenant for debt service in relation to the Sewer Bond Series 2007 A.

NOTE 12- LITIGATION

The City is not aware of any pending or threatened litigation in which it is involved which would have a material effect on these primary government financial statements.

NOTE 13 - CONTINGENT LIABILITIES

The City is a participant in the Commonwealth of Kentucky's Municipal Road Aid program. This program is subject to program compliance audits by the grantors or their representatives. The audit for this program has not been conducted for the year ended June 30, 2024. Accordingly, the City's compliance with applicable grant requirements will be established at some future date.

Report on Internal Control Over Financial Reporting

In planning and performing our audit of the financial statements, we considered the City of Corydon, Kentucky's internal control over financial reporting (internal control) as a basis for designing the audit procedures that are appropriate in the circumstances for the purpose of expressing our opinions on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the City of Corydon, Kentucky's internal control. Accordingly, we do not express an opinion on the effectiveness of the City of Corydon, Kentucky's internal control.

A *deficiency in internal control* exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A *material weakness* is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented or detected and corrected on a timely basis. A *significant deficiency* is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Our consideration of internal control was for the limited purpose described in the first paragraph of this section and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and therefore, material weaknesses or significant deficiencies may exist that were not identified. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. We did identify certain deficiencies in internal control, described in the accompanying schedule of findings and responses that we consider to be significant deficiencies. (2024-01 and 2024-02)

Report on Compliance and Other Matters

As part of obtaining reasonable assurance about whether the City of Corydon, Kentucky's financial statements are free from material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the financial statements

However, providing an opinion on compliance with those provisions was not an objective of our audit, and accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards*.

City of Corydon, Kentucky's Response to Findings

The City of Corydon, Kentucky's responses to the findings identified in our audit are described in the accompanying schedule of findings and responses. The City of Corydon, Kentucky's responses were not subjected to the auditing procedures applied in the audit of the financial statements, and accordingly, we express no opinion on them.

Purpose of this Report

The purpose of this report is solely to describe the scope of our testing of internal control and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the entity's internal control or on compliance. This report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the entity's internal control and compliance.
