## SECTION 2.

The budget ordinance shall be administered by the executive authority as prescribed and set forth in the Kentucky Revised Statues. Administration shall include, but not limited to, at least the following:

- A. Preparation and submission of financial statements which include budgetary comparisons on not less than a quarterly basis.
- B. Provide for budget amendments if called for by the Council or if anticipated through implementation.
- C. Prepare any financial statements required for publication purposes, pursuant to KRS 424 and 91A.
- D. Cause each fund of the budget to be audited as prescribed by law.

SECTION 3: This ordinance shall be published in a newspaper by title and summary within thirty (30) days after adoption.

SECTION 4: The ordinance becomes effective immediately upon passage and publication as required by law.

First reading: May 30, 2024. Motion made by Councilmember Beth French to approve the first reading of the 2024-2025 budget. Second by Councilmember Karen Curl. Roll call: Karen Curl-Aye, Nathan Grace-Aye, Beth French-Aye, Jayla Gish-Aye Absent Councilmembers Kristi Phillips and Michael Burkes. Motion carried.

Second reading: June 20, 2024. Motion made by Councilmember Karen Curl to accept the second reading of the 2024-2025 budget. Second by Councilmember Jayla Gish. Roll call: Karen Curl-Aye, Nathan Grace-Aye, Jayla Gish-Aye, Kristi Phillips-Aye Absent Councilmembers Michael Burkes and Beth French. Motion carried.
