1. **Cancellation by a customer**

Cancellations should be advised in writing by email to hello@fit2communicate.com.

Should any training or workshops be cancelled the following scale will be applied:

- Cancellation received by Fit2Communicate Limited more than 20 working days before the scheduled event will not incur any charges.
- Cancellation received by Fit2Communicate Limited between 5 and 20 working days before the scheduled event you will be charged 50% of the agreed fee.
- Cancellation received by Fit2Communicate Limited less than five working days before the scheduled event you will be charged 100% of the agreed fee.

The notice period for cancelling a consultancy contract is 28 days, therefore the following scale will be applied to any cancellations:

- Cancellation received by Fit2Communicate Limited more than 20 working days before the scheduled contract start date will not incur any charges.
- Cancellation received by Fit2Communicate Limited less than 20 working days before the scheduled contract start date you will be charged 50% of the notice period.
- Cancellation received by Fit2Communicate Limited during the contract term you will be charged 100% of the notice period.
