

#### **NEW!** Forest Hill Ave Sewer Work Updates from DPU

Date: Tuesday, August 19

**Time**: 6-7:30 p.m.

**Location**: Virtual (see meeting access instructions via this **flyer** and/or **press release**) **Purpose**: The utility work necessitated by the sewer collapse on Forest Hill Ave last year always required a second phase - which we are now at. DPU is hosting this meeting to share the work that will be completed, lane closures/traffic impacts, and efforts they are taking to minimize the disruption, particularly to our small businesses. I have reiterated the importance of frequent and clear communication from DPU - as well as prioritizing the well-being of our small businesses, and will work continuously to ensure DPU keeps this commitment.

# 4th District Dialogue: Cherokee Road Improvements & Traffic Safety on/around Chippenham with RPD and DPW

Date: Monday, August 25

**Purpose**: During the first half of the meeting, DPW will share the latest updates on Cherokee Road improvements (including interim measures) and RPD will discuss traffic enforcement efforts in the area; both DPW and RPD will answer questions and take feedback. During the second half of the meeting, DPW and RPD will address concerns regarding speeding on/around Chippenham, including enforcement and any other mitigation measures. Given the overlapping constituencies, Chesterfield Supervisor Mark Miller and representatives from the Chesterfield County Police Department will also be in attendance and participating.
