## LIABILITY WAVIER

### 1. Assumption of Risk

The Owner acknowledges that all animals may act unpredictably, even when under supervision. The Kennel will take all reasonable precautions to provide a safe environment; however, the Owner voluntarily assumes all risks associated with boarding their pet(s), including but not limited to injury, illness, escape, or death.

### 2. Health and Vaccinations

The Owner affirms that their pet(s) are in good health and have received all required vaccinations, including but not limited to rabies, kennel cough, distemper and flea medication. Casey's Pet Haven reserves the right to refuse services for pets without proof of up-to-date vaccinations.

### 3. Veterinary Care

In the event of illness or injury, Casey's Pet Haven will attempt to contact the Owner immediately. If the Owner or Emergency Contact cannot be reached, the Pet Haven is authorized to seek veterinary care at its discretion. The Owner agrees to be fully responsible for all veterinary costs, including transportation and treatment.

### 4. Release of Liability

To the fullest extent permitted by the laws of Prince Edward Island, the Owner hereby releases, waives, and holds harmless Casey's Pet Haven, its owners, employees, and representatives from any and all claims, liabilities, damages, or losses arising from or in connection with the services provided, including but not limited to:

- Injury or illness to the Owner's pet;
- Injury or damage caused by the Owner's pet to other animals, people, or property;
- Natural disasters, fire, theft, or other unforeseen events.

### 5. Abandonment

If the pet is not picked up within five (5) days of the scheduled pick-up date, and no communication has been made by the Owner, Casey's Pet Haven reserves the right to take appropriate action, including placing the pet with the Prince Edward Island Humane Society, in accordance with the Prince Edward Island Companion Animal Protection Act.

### 6. Personal Items

Casey's Pet Haven is not responsible for any personal items left with the pet, including beds, toys, or leashes.

### 7. Photography and Promotion

The Owner agrees that photographs or videos of their pet may be used for marketing, promotional purposes, or on social media, unless otherwise noted in writing.

### 8. Governing Law

This agreement shall be governed by and construed in accordance with the laws of the Province of Prince Edward Island and the laws of Canada applicable therein. Any disputes shall be resolved within the jurisdiction of Prince Edward Island.

### 9. Entire Agreement

This agreement represents the entire understanding between the parties. No other representations, warranties, or promises, whether written or oral, are binding unless in writing and signed by both parties.
