Directions to the stalls

From the North:

Travel south on I-5 to Exit 258. Turn right onto Portland Rd, follow to Lana Ave NE. Turn left at the light onto Lana Ave NE. At the end of Lana Ave NE, there is a stoplight. Proceed straight through the light, crossing Silverton Rd NE, entering grounds. Follow gravel road to horse barn.

From the South:

Travel north on I-5, to Exit 256. Turn left onto Market St NE. Proceed on Market Street NE to 17th St NE and turn right. Continue straight on 17th Street to Silverton Rd NE and turn right. Proceed on Silverton Road to the light at Lana Avenue NE and turn right into the lot. Follow gravel road to horse barn.

Never Won a Buckle

Classes Offered: Halter and Showmanship

Beginner Class Rules:

- Exhibitor may not have won a buckle or more than 10 points in any Breed approved competition as of the date of the show weekend in the class entered.
- Class winner is awarded a belt buckle.
- Appropriate attire is required for the class being entered.
- Horses do not need to be a registered Paint Horse to show in the beginner class. The exhibitor does not need to own the horse. Rider/exhibitor may cross-enter into other APHA classes at the show but must meet all ownership and membership requirements for APHA classes.
- Beginner Halter is open to mares or geldings of any age to compete in the class.
- Beginner classes are open to youth and amateurs.
- If it is determined that an exhibitor is ineligible for a beginner class, they will be disqualified, and any awards will be forfeited.

Judges Command Jackpot

Judges Command Jackpot Class Rules:

- Jackpot classes are open to youth and amateurs.
- Appropriate attire is required for the class being entered.
- Horses need not be a registered Paint Horse to show in a Jackpot class. Exhibitor does not need to own the horse.
- Class will be a rail class, judged on both rider and horse as they perform requested maneuvers by judges.
- Classes will be judged by all 4 judges and the average of your best 3 placings will determine your overall placing.
- Points will be awarded as follows: 1st- 6 pts, 2nd 5 pts, 3rd 4 pts, 4th 3 pts, 5th 2pts, 6th 1pt The exhibitor with the most points shall be declared the winner.
- TIES in the event of a tie, a tie-breaker judge shall be designated in advance to determine who shall receive the award.
- All classes will be run according to APHA rules. Contact show management if you need a copy.
- Payout based on the number of entries after \$5 office fee from each entry deducted.
 - 1 3 entries 100% payout to first place
 - 4 8 entries 70% payout to first place, 30% to second place
 - 9 or more entries 50% payout to first place, 35% to second place, 15% to third place

Show Rules

Make all checks payable to Oregon Paint Horse Club. NO POST-DATED CHECKS. There will be a \$50 fee assessed EACH time a check is returned by the bank.

- 1. An entry in the Spring Fling show is considered an entry under ALL judges.
- 2. Exhibitor Responsibility: SC-160.E-Exhibitors are responsible for being knowledgeable of and following the current rules, completing entry forms legibly and accurately, reporting to the gate promptly and being considerate of other exhibitors and show management. Additionally, exhibitors, owners and trainers are responsible to be knowledgeable of Rule SC-085 Drugs and Medications, forbidden, permitted & conditionally permitted substances. Conditionally permitted substances require a completed medication report be filed with show office. Inhumane treatment of animals on the grounds will not be tolerated. Rule SC075. Proper action WILL be taken.
- 3. The Show Secretary or Office Staff MUST inspect the registration papers (or copies of) on each horse entered (except current year foals). Entries shall be made in the name of the recorded owners Rule SC 160.C. Geldings are not allowed to show with stallion papers Rule SC 160.I.3.
- 4. Leased Horses the show secretary or office staff MUST inspect the APHA show lease certificate according to rules AM-020.A.1.F & YP-015.A.2.F.
- 5. To enter Amateur or Novice Amateur classes, you MUST present a current year APHA Amateur or Novice Amateur card, and own your horse according to Rule AM-015, AM-210, and AM-300.C.
- 6. Novice Youth MUST present a current Novice Youth Card from APHA in order to enter any Novice Youth Class, Rule YP-210. Additionally, Novice Youth may cross enter into the age-appropriate Youth Class. Youth must present an AjPHA membership card in order to enter any youth classes (exception being Leadline and Walk/Trot) Rule YP-005.A.5
- 7. If showing APHA walk/trot no cross entry into all-breed canter/lope classes.
- 8. All Exhibitors AND Owners must present a current APHA membership card. Rule SC-160.A. The condition of submitting entries or the first entry into the show ring of a horse or exhibitor shall be deemed as acceptance of the APHA Official Rule Book and the Oregon Paint Horse Club general rules.
- 9. The final right to settle all questions or disputes arising incidentally to the Oregon Paint Horse Club is reserved to the Show Management. All exhibitors, owners, and trainers, as condition of admission, give unqualified consent to such methods of settlement and agree in advance to be bound thereby.
- 10. Show management may combine or split classes according to APHA rules SC 185.G, AM 080.B, and YP 075.B. 11. Anyone withdrawing (scratching) from a class after class has began, shall forfeit their entry fee in accordance with Rule SC-185.A.
- 11. Exhibitors/Owners competing for Oregon Paint Horse Club show, are responsible for entering the correct classes to qualify for all awards. Award qualifying class lists will be available as the show.
- 12. Stall and/or circuit refund with vet/doctor note provided no more than 7 days after the show's completion. The show secretary must be notified prior to the start of the first class entered.
- 13. One/Horse/One Rider combination to apply to all Youth & Amateur High Points.
- 14. ALL DOGS MUST BE ON A LEASH.
- 15. Participation Agreement, Notice Release, and Acknowledgement of Risk: I accept and clearly understand that riding a horse can be hazardous, especially in an equestrian event; that there are inherent and other risks involved in riding a horse; and that injuries are a common and ordinary occurrence. I freely accept and assume those risks. I therefore release Oregon Paint Horse Club and Southwest Washington Paint Horse Club members and show grounds' owners and all their agents and employees, from any and all liability for damage and injury to myself, my horse, or to any person or property resulting from my riding a horse in this equestrian event, accepting myself the full responsibility for any and all such damage or injury of any kind which may result. I agree to fully indemnify, defend, and hold OPHC, show grounds' owners and all of their agents and employees, harmless from any and all claims, actions, liability, or costs including attorney fees and other costs of defense, arising out of or in any way related to my riding a horse in this equestrian event. The limitations on liability provided in ORS 30.691 shall apply to an adult participant in the circumstances listed in subsection (1)(b) of this section if the participant, prior to riding, training, driving, grooming or riding as a passenger upon an equine, knowingly executes a release stating that as a condition of participation, the participant waives the right to bring an action against the equine professional or equine activity sponsor for an injury or death arising out of riding, training, driving, grooming or riding as a passenger upon the equine. A release so executed shall be binding upon the adult participant. I hereby certify that every horse is eligible as entered. I make these entries at my own risk and understand that equine events are potentially dangerous. Show management, owners of the facility, and/or OPHC shall not be held responsible for any accident, injury or loss that may occur to any exhibitor, their representatives, or to their horses, equipment, or vehicles. Presentation of this entry with my entry fee shall be deemed acceptance of the above. I understand and agree that this show shall be conducted under the rules of APHA, OPHC, SWWPHC and that of the Show Management.
