NSDT reserves the right to close or cancel a camp that doesn't meet the minimum enrollment NSDT deems necessary to cover expenditures. NSDT class age groupings are guidelines. NSDT retains the right to place students in classes at directors' and teachers' discretion. NSDT retains the right to provide substitute teachers in the event of the absence of regularly scheduled teachers.

Due to COVID-19, we have limited capacity for camps. All camps will meet in-person providing that local and state guidelines and restrictions allow. In the event that in-person camps are not allowed, camps will be held virtually over Zoom or another web-based video platform. Virtual camps will require downloading the Zoom or another web-based video platform onto a phone, tablet, or computer. A link to the virtual classroom will be emailed to you prior to the class. By using these platforms, campers will be able to interact with the teaching team and each other in real time from home. NSDT is not responsible for internet/Wi-Fi outages or connectivity issues with the camp's Zoom or other web-based video platform app or website.

Students will not be invoiced for tuition. Parents or Guardians are responsible for making payments at the correct times, and are subject to additional fees in the event tuition is not received on time. If a child doesn't like their role in the camp and chooses to drop out, there will be no refund. Camps will not be pro-rated. NSDT accepts exact cash, check and credit card payments; there is a \$25 fee for returned checks. NSDT has a no refund policy with the following exceptions:

- If the in-person camp session is not allowed due to local or state guidelines, camps will be held virtually. If you do not wish for your child to participate at that time, a 50% refund will be granted if you email NSDT of your cancellation within the first 48 hours of receiving notification of the change.
- If your child or household member test positive for COVID-19 within two weeks of the first day of camp, the infected member must show a negative test result within the past 48 hours before your child can begin camp. In the event that the infected member does not test negative by the first day of camp, a 50% refund will be granted.
- If your child or household member test positive for COVID-19 during the camp session, your child will not be able to attend camp for the remainder of that session. A \$50 credit towards a future class, camp or production will be issued. The credit will be valid through 9/30/2022, additional terms and conditions apply.

Tuition and registration are due on or by 5/31/2022. If spots are available, late registration will be accepted up to one week prior of the beginning of each camp at a \$15 late fee. Spaces in camps will not be held if tuition has not been received during regular registration time.

Parents/Guardians are responsible for checking their email daily for newsletters, updates and any other information. Students are responsible for wearing proper attire (including dance shoes). If these rules are not followed, the student will be asked to leave camp or sit out for the day. This is to ensure safety and fairness.

The North Shore Dance & Theater provides educational opportunity without discrimination on the grounds of race, sexual orientation, color, creed or religion, gender, national origin or age.
