

# GREENSHORES ON LAKE AUSTIN PROPERTY OWNERS ASSOCIATION

## **Community Park Party Request**

**RESERVATIONS** – Only Members of the Association are eligible to reserve the Community Park and must make reservations and obtain prior written approval of the Association. Reservations must be made in writing to the Association at least fourteen (14) days and no more than sixty (60) days in advance of party date.

Use of the facility may be prohibited if Member's previous use resulted in damages or abuse of the facility, if member is not in compliance with the Association Restrictions and Rules, or if member is delinquent in payment of assessments.

**NUMBER OF GUESTS** – The maximum number of guests for any one event is 30.

**COSTS** – There is not a user fee currently. However, a deposit of \$100 per party reservation application is required. These fees must be paid at time of application. The application will be considered incomplete without payment and will not be reviewed. The user fee and deposit will be refunded if the facilities are not used due to inclement weather or if written cancellation is received in Association office 24 hours in advance. The deposit will be refunded if there is no damage as a result of the party, the area is returned in the same condition as it was received prior to the party, and vacated by the curfew time.

**RULES** – Users are required to observe all of the rules of the Association, including, but not limited to, the following:

1. The Member making the reservation must be present for the duration of the party.
2. Warning – No lifeguard on duty. Swimming and use of all Community Park facilities is at your own risk.
3. No diving, somersaults, back dives, cannon balls, preacher seats, can openers, or similar type of entries from the edge of the docks and Community Park into Lake Austin.
4. Children under the age of 15 are prohibited from using the Community Park without adult supervision.
5. Proper clothing must be worn at all times.
6. Adults are encouraged not to swim alone.
7. Absolutely no glass containers.
8. No drugs, fireworks or weapons of any kind whatsoever allowed.
9. No unsafe and disorderly activities allowed.
10. All animals must be controlled by their owners at all times.
11. Owners must remove their pet's waste from the Community Park.
12. Nuisances, such as loud music and inappropriate behavior, are prohibited.
13. Open fires are strictly prohibited except in the fire pit provided by the Association.
14. Dispose of all litter! Keeping this area clean is everyone's responsibility. Members are required to remove all trash and clean any messes caused by their party.
15. No one shall knowingly enter the Community Park while suffering from any contagious diseases.
16. Report any damage to the Community Park immediately to Jack Baker, Community Association Management, by calling 413-5775.
17. Violations of the Rules and interference with the enforcement of the Rules may result in the assessment of fines and other penalties.
18. Damages to the Community Park and any other property owned by the Association may result in the assessment of repair and replacement costs, fines and other penalties.
19. No sign, banner, or decoration will be allowed to be affixed to any surface. Signs and decorations displayed in connection with an event at the Community Park must obtain prior written approval of the Architectural Committee.

20. Owners are responsible for any damage they, their guests, or their children cause while using any of the Community Park facilities and for cleaning up any mess or trash created by them prior to leaving the area.
21. The community manager may deny access to the Community Park at any time due to occupancy limits, weather, condition of the Community Park or if maintenance is required.
22. At the discretion of the community manager and as approved by the Board of Directors of the Greenshores on Lake Austin Property Owners Association, certain periods of the normal operating hours may be set aside for specialized activities. These activities will be open to all interested residents. Scheduled times for these activities will be posted.
23. Use of Community Park facilities may be denied if Association fees or other due amounts remain unpaid.
24. Violations of these Rules and interference with the enforcement of these Rules may result in (a) temporary revocation of Member privileges, (b) suspension of Member privileges, (c) fines or assessments, and/or (d) legal action against the violator. Dispose of all litter! You must remove from the premises everything you brought into the Community Park.
