Red (ee) is the base coat color for this horse. Chestnut/Sorrel consists of a red or dark red/liver coat, with a mane and tail of similar or lighter color. Horse has a 100% chance of passing Red to any offspring.

Tobiano (TO) - TO/TO

TO/TO - Two Tobiano (TO) variants detected; may result in large white markings on body, face and legs (occasionally produces 'minimal' or 'slipped' Tobiano horse with very little white only on face and lower legs (ongoing heritability study for minimal Tobiano). Horse has 100% chance of passing to any offspring.

STALLION OWNER: 14 Karrot Ranch LLC, Mark & Shannon Newell Mobile (602) 509-4085

BREEDING FEE: The Mare Owner agrees to pay a breeding fee of \$ _____ (USD) plus a \$250.00 non-refundable booking fee payable with this contract. Any deviation from these terms must be specified in writing and signed by Stallion Owner or Agent. **Booking fee is due on all contracts, regardless of stud fee, discounted, donated or special consideration breedings and is due and payable when this contract is signed and prior to any mare being bred.**

Each AI shipment must be paid in full before or at the time of semen order and will be \$ 275 _____, sent via FedEx. Please keep in mind, Saturday delivery & Counter to Counter IS NOT CURRENTLY available due to the location of the farm. Cooled semen may be picked up at the farm with advance notice.

Balance of stud fee due when mare is picked up from farm, or prior to first AI shipment. No mares will be included on any AQHA, APHA or PtHA stallion reports for foal registration for which there is an outstanding balance owed to Stallion Owner or Stallion Manager. All payments must be made payable to 14 Karrot Ranch, LLC.

BREEDING SEASON: The breeding season is from February 15 to June 15, 2024.

REGISTRATION PAPERS: Mare Owner shall provide a copy of Mare's Registration Papers (front and back) at the time of execution of the Breeding Contract. The owner of record on the registration papers will be listed as the "Mare Owner" on the Stallion Breeding Report(s), unless a lease or other ownership documents are provided, proving otherwise.

COLLECTION AND SHIPPING SCHEDULE: Mare owner must order semen (and notify Stallion Manager of shipping order via Phone or Text) 24 hours in advance. Collections are done Monday, Wednesday, and Friday. If the Stallion Manager is able to fulfill a late request, a rush fee of \$100.00 will apply. We cannot guarantee delivery on late calls but will do our best to provide service. Stallion Manager or Owner reserves right to deny shipping requests for any reason including late requests received after the cut off time.

MARE BREEDING CONDITION: **Mare Owner** represents and warrants that the mare is in sound breeding condition and free from infection and disease. Any mare certified by the attending veterinarian not to be, in their opinion, in sound breeding condition, shall not be bred. Upon that determination, **Mare Owner** may substitute another mare within that breeding season for breeding to Stallion, subject to all the terms and conditions of this breeding contract. If multiple shipments are requested, **Stallion Owner** reserves the right to request a negative uterine culture, cytology, or biopsy prior to sending further shipments.

COOLED SEMEN HANDLING: **Mare Owner** agrees to assume responsibility for all the facets of breeding the mare and agrees to comply with all APHA, AQHA, or any other breed registry requirements as applicable, concerning the use and handling of cooled semen. The **Mare Owner** agrees that a licensed veterinarian or **certified breeding manager** who is qualified and experienced in the use and handling of cooled semen will perform the insemination. **Mare Owner** agrees to use all semen provided by this Agreement solely to breed the mare named in this contract.

LIVE COVER/ON FARM BREEDING: **Mare Owner** agrees to assume ALL risks and responsibility for all the facets of breeding the mare and agrees to comply with any and all rules or requests of the Stallion Manager, their farm and staff while mare is on the property or housed at their facility. Mare Owner releases Stallion Manager and Owner from liability for any injury or death to the mare, or the mares foal, if delivered with a foal on their side, while at the farm. Mares must be delivered with a current shot record, **back shoes pulled** and any special feed or supplements. All mare care, vet, breeding and/or boarding fees must be paid in full **at time of pick up**. For the safety of the mare and stallion, Stallion Owner recommends that mares are inseminated on site after stallion is collected. All ultrasounds and medicine, shots or other vet work required, will be the full financial responsibility of the Mare Owner.

****MARE CARE IS \$12/DAY DRY & \$15/DAY WET; FOAL OUT \$350****

LIVE FOAL GUARANTEE: Live foal means that the foal resulting from the breeding stands and nurses without assistance and lives for 24 hours. It is understood that if the mare proves barren, aborts her foal or if the foal is born still-born, a return season will be guaranteed the following year only, provided proper notification is received as follows: Written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. **Mare Owner** certifies that such abortion or death did not result from act or omission of the **Mare Owner**. If the **Mare Owner** fails to rebreed the mare the subsequent breeding season, then any and all fees become forfeited, the right to rebreed is cancelled and the **Stallion Owner** is released from all further obligation of this contract unless otherwise agreed in writing.

MULTIPLE FOALS: This agreement provides for one foal for the 20__24__

breeding season from this mare. Should more than one viable foal result from such breeding, the **Mare Owner** shall pay an additional Breeding Fee for each additional embryo or resulting foal. Such payment shall be due in full within 30 days of successful embryo transfer of each additional foal, or birth of foals, if twins resulted from a single mare, in order to receive a certificate for additional foals.

BREEDER'S CERTIFICATE: Stallion Owner will require notification of breeding dates in order to submit appropriate stallion breeding reports for your mare. After all fees and expenses have been paid, a Breeder's Certificate will be issued to the **Mare Owner for APHA, PtHA and AQHA; or any other applicable breed registries .**

ASSIGNMENT OF CONTRACT: In the event the mare is sold prior to foaling, the live foal guarantee portion of this contract will transfer with the mare to the new owners. In the event the mare should die, become unbreedable or is sold prior to insemination, the **Stallion Owner MAY** agree to substitute another mare for the **Mare Owner ONLY.**

TERMINATION: If the Stallion dies, is sold, or becomes unfit for breeding during the breeding season prior to mare being inseminated, then this contract shall become null and void and any booking fees paid shall be refunded .

RETURNED CHECK/DISPUTES POLICY: In the event the Mare Owner's check is returned for any reason, including insufficient funds, **Mare Owner** is responsible for a returned check fee in the amount of \$50.00. Reimbursement to cover returned check and returned check fee must be made by money order, cashier's, certified check or by credit card.. Any returned checks for which the balance owed is not paid within 30 days, or any Credit Card or Paypal disputes for fees paid filed by the Mare Owner will automatically void this contract and all guarantees herein and Stallion Owner may take any and all legal steps necessary to recover funds owed by Mare Owner.

WARRANTY: No warranties whatsoever, expressed or implied, shall accompany a breeding within this Agreement. No guarantee of delivery of shipped semen within a certain time period or guarantee that shipped semen will safely reach the insemination point without losing some integrity, quality or characteristics is given by this Agreement. Stallion Manager and Owner will work diligently with Mare Owner to work towards a successful pregnancy, but cannot guarantee mare will get in foal for reasons including but not limited to: mother nature, weather, shipping delays, mares uterine condition, mares reaction to extender (if this is a known condition, Mare Owner is responsible to let Stallion Manager/Owner

know ahead of time and prior to collection), mares age, semen motility upon receipt, any other biological factors which may impede or be affected by these conditions.

EXECUTION: When Mare Owner signs and returns one copy of this contract to the Stallion Owner, along with the PAID booking fee it will be a binding contract on both parties, subject to the terms and conditions under Arizona Law.

VENUE AND JURISDICTION: This entire contract will be governed by the laws of the State of Arizona. The parties hereby specifically agree that this Agreement shall be construed, governed and interpreted by and in accordance with the laws of the State of Arizona. In any action or arbitration is brought to enforce or interpret the terms of this Agreement, the proper place of venue shall be Yavapai County, Arizona.

To Order Semen:

* **Please Call and Text** Stallion Manager AT __602-509-4085____ at least 24 hours in Advance on the date you need semen. Please be sure to leave a clear message with the date and time of your call, your name, your mares name, phone number and the date you need the semen shipped.

* Stallion is collected Monday, Wednesday and Friday. It is the at the Stallion Managers discretion to fulfill any request that falls outside of these parameters and an additional \$100 RUSH fee will apply. Counter to counter is not currently available.

* If local, arrangements can be made to pick up the semen at that farm in Chino Valley, Az.

* Payment in full in the amount of \$___275_____per shipment is due at the time it is ordered and semen will be shipped via Fed Ex. Semen will be shipped in a container provided by the Stallion Manager and should be returned back within 2 days.

* Shipment fees are subject to change due to shipping costs and airline fees (when available).
