






FEDERAL AFFIDAVITS INSTRUCTIONS

Unlawful Arrest And Familial Interference

ABSENT OF INDICTMENT: Anyone who has been arrested for and/or charged with a felony without a grand jury indictment *or* has witnessed these crimes being committed against a family member **has the right to file Federal Affidavits of Criminal Conspiracy for Unlawful Indictment and Arrest.**

UNLAWFUL REMOVAL OF CHILDREN: Parents and relatives of children who were unlawfully taken also **have the right to file Affidavits of Criminal Conspiracy for Unlawful Interference with the Familial Unit.**

That includes:

-  ***Grandparents***
-  ***Aunts & Uncles***
-  ***Cousins***
-  ***Step-parents & Step-grandparents***
-  ***Anyone Bonded by Blood or Law (Marriage)***

The Fifth Amendment protects against hasty and malicious charges, and the First and Fourteenth Amendment protects the right of familial association.

 ***Indictment by Information Victims Should:***

- ***Complete 1 Affidavit for Yourself***
- ***Ask Family Members to Complete 1 Affidavit with You as the Victim, Signed by***

 ***Parent and Relatives of Unlawful Child Removals Should:***

- ***Complete 1 Affidavit for Yourself for Each Child***
- ***Complete 1 Affidavit for Each Child Listing Each as the Victim***

 ***HOW TO COMPLETE YOUR AFFIDAVITS – Use BLUE ink!***

Follow these exact instructions:

- Use the first date your rights were violated in both the first and second paragraphs.
- The victim is you and/or the child(ren). Each victim gets their own affidavit.

- On Page 2, put your name in the first blank. You are the witness to the crime!
- Sign on the bold signature line, and print your name clearly underneath.
- Where it says “prosecuting attorney” on my example (Downloads on Website):
 - If a family court judge violated your rights, write: “Prosecuting Attorney”.
 - If CPS took your children, write: “Child Protective Services”.
 - If a police department took your children, write “Police Department”.

Further Clarification:

I have 2 children--Wyatt and Adalynn. I will submit one affidavit for each child with me being the victim because they interfered with **both** my children, and I'll submit one with each child being the victim--4 total affidavits.
