Cindy Urmos-Clements Telluride! Nestled in the San Juan Mountains in Southwest Colorado, Telluride Ski Resort offers the most stunning skiing and riding on the continent. Experience our unrivaled scenery and terrain, shopping and spas and the ease of the free Gondola that connects both historic Telluride and the European Mountain Village. The most beautiful place you will ever ski. Still with many reminders of the mining town it once was but now is one of the west's most popular ski resorts. From the back bowls to the 4.6 mile Galloping Goose run, Telluride has over 2,000 skiable acres, with 127 trails served by 18 lifts. The elevation varies from 8,750' to 12,255' with an average annual snowfall of 309". The trails have a mix of 23% beginner, 36% intermediate and 41% advanced/expert.

We will be staying at a variety of condos as we were unable to get condos at one location for our group this year – we have condos reserved at Etta Place 2, Cimarron and Double Diamond. Cimarron is ski-in/ski-out via Lift #7 (Coonskin Lift). Etta Place 2 is Ski-in/Ski-out access. Double Diamond is a short 75 yards from the #7 Lift. We are staying close to the Town of Telluride which will put us close to everything that Telluride has to offer, but we are still right there at #7 lift! We are excited to see what staying close to town has to offer our group, many in our club have stayed in town before, so it's nothing new for our club.

The free in-town Galloping Goose Shuttle stops right across the street. Double-Diamond is located a short 75 yards from the base of Lift #7 in the town of Telluride.
