A Tradition Continues



Six-year-old Madison Wells loves to fish. Her parents, Brian and Katie, purchased the Wells Cottage from Brian's father, Howard, in 2016 and have become regular vacationers on the lake ever since.

In an interview with Madison, she stated that her favorite fishing spots were

just behind the island (south side), in the North Cove and right on her own dock. Her brother, Connor, also fishes, but he too, is impressed by his sister's angling skills. Madison likes to fish with a variety of colored lures as well as worms. Her favorite lures are Strike King-Slime Stick (best used right around dinner time) and the Zoom-UTale with the black and red glitter,

which she uses in the morning and afternoon.

Madison stated that her "trick" for getting fish off the hook with the least damage is done using surgical forceps. She recalled a day last summer when she caught 13 fish in one hour. All were released. Of course, not all fish are release and she recalled one time her family friend JoJo caught a huge bass (4.8 pounds) which they did eat for dinner.

Her dad has been her instructor, and he does keep some stats for her. "The longest fish Madison ever caught was 13 inch largemouth bass."

The hardest part about fishing "is waiting!" but Madison seems to take it all in stride.

- Weed removal We will work again next year to rake and remove floating plants. Carl Grillo will be the contact person (315) 696-5963
- Benthic mats at swimming areas Action timed for spring 2020 Look for the emails with specific dates and instructions.

Resident Choices and Best Practices

- Create shorescapes and shoreline buffers to reduce stormwater nutrients and other pollutants. Find out more by attending the workshop, <u>Protecting Water Quality in the Kettle Lakes and</u> Beyond, March 24, from 5:30 7:30 (dinner provided). Register by calling 315-443-3741.
- Keep boats in deeper water to limit resuspension of sediments into the water column and erosion along the shoreline. Please use the bathymetry map provided here with the Anglers' Survey.
- Keep septic system clean by pumping (every 3 years) with proper maintenance. SLPOA will continue the septic system incentive program. **This offer is available on the website!**

Ongoing

- Coordination with Cortland County Soil & Water for shoreline buffers and shorescaping.
- Continue to work with the experts as we monitor the changes occurring in the lake.
- Toxic Cyanobacterial Harmful Algal Bloom Monitoring.

We work with many experts including close contact with the DEC Lakes Monitoring Program, professionals within NYSFOLA, and experts within our local universities including SUNY-ESF and SUNY Oneonta.

CvanoHABs

Song Lake has a long history of toxic algal blooms. Just be aware, and if you see a suspicious area, please do the following: 1st) Keep pets and children out of the water for 24 to 48 hours in that area. 2nd) Take a picture and send it to our email at songlakeassociation@gmail.com or text it to Tarki at 747-876-2198. 3rd) Call either Tarki or Carl Grillo 315- 696-5963 so we can grab a sample to have it tested for toxicity.

Boater Safety – New Law

You will soon need to complete a safety course to operate a motorboat in New York, regardless of when you were born.

Gov. Andrew Cuomo signed <u>a bill into law</u> in August that will gradually expand the state's safety-course mandate, requiring anyone operating a motorboat or Jet Ski in New York to complete the training offered online or in a classroom.

Brianna's Law, as the new law is known, will be phased in over six years, applying first this year to those born in 1993 or later before gradually including all motorboat operators by 2025.

The law is named after Brianna Lieneck, an 11-year-old girl killed in a 2005 boat crash off Long Island.

The new law applies to anyone operating a "mechanically propelled vessel" in navigable waters anywhere in New York. It does not apply to non-motorized crafts, such as canoes, sailboats, stand-up paddle boards and kayaks.

Previously, only those born after May 1, 1996, had to complete a safety course to operate a motorized boat. And even then, those under the age of 18 could still operate the boat without taking the course if they were accompanied by an adult.

You have to be at least 10 years old to operate a motorboat in New York or 14 to operate a personal watercraft, such as a Jet Ski.

The law, which took effect Jan. 1, requires:

In 2020, all motorboat operators born in 1993 or later to take the safety course.

In 2021, it applies to those born on or after Jan. 1, 1988.

In 2022, those born on or after Jan. 1, 1983.

In 2024, those born on or after Jan. 1, 1978.

In 2025, everyone regardless of age.

The state Bureau of Marine Services offers the safety course in a classroom setting at sites across the state. At least a half-dozen companies also offer the course online. Fees for the course vary, though the state charges those over the age of 18 a \$10 fee for the issuance of a safety certificate once the course is complete. Boatus.org offers the only free on-line safety course approved by the state. For more information, visit the State Park's boating website at parks.ny.gov/recreation/boating.
