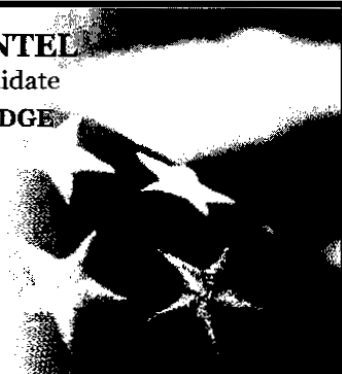
Take a drive to Petaluma for the Great Petaluma Chili Cook-Off on May 8th at the Sonoma-Marin Fairgrounds.

FROM THE LAW LIBRARY

As many of you are aware, county government is facing a significant shortfall in funding. There are several reasons for this, but it is mostly a result of unprecedented decreases in discretionary revenue as well as the State budget crisis. The Modesto Bee reported on action that the Board of Supervisors took in early April to cut salaries and wages by five percent (5%) across the board. As I understand it, departmental program and staffing reductions is part of a thirty (30) month budget strategy to allow for the restructuring of revenues and expenditures. These Labor Cost Reduction Agreements, which include other strategies in addition to the five percent (5%) salary reductions, is intended to provide direct salary cost savings during the next two (2) fiscal years.

Civil filing fees from sources such as Probate, Family Law, and Personal Injury lawsuits support over eighty-five percent (85%) of law library operations. However, the Law Library does receive monies from the County General Fund, and as such, our operations will be affected.

Salary reductions and furlough days will be a part of the future beginning July 3, 2010 and ending June 30, 2012 (two Fiscal Years). How this will affect the services the Law Library delivers to you has yet to be determined.

We will be conducting a survey, which will be emailed to our qualified borrowers. We respectfully request you to complete it and return it promptly. For others, the survey will be available to fill out in the library. The survey is designed to determine how our patrons use the library and what the preferences are regarding hours of operation.

While final decisions regarding closures, reduced hours, and diminished services will be determined by the Law Library Board of Trustees, feedback from the legal professional community will certainly be considered. As always, the ultimate decision will focus on cost savings and efficiencies while endeavoring to strike the correct balance to meet the needs of our library patrons.

FROM THE COURT



A NEW COURTHOUSE FOR THE SUPERIOR COURT

The Office of Courthouse Construction Management (OCCM) a department within the Administrative Office of the Courts (AOC) has recommended a new courthouse in a new location. Yes, you read that correctly. Senate Bill 1407 created the courthouse construction bond money and we have been advised by OCCM that our new 26 department courthouse is moving forward with a price tag of \$277,000,000. There is a process that has to happen before groundbreaking can take place. A Project Facility Report has been prepared and it will reach the Department of Finance (DoF) sometime in late April. Thereafter the process will involve the Joint Legislative Budget Committee (JLBC) and the State Public Works Board.

The time line for this project once approved by the DoF and the JLBC is as follows: The site acquisition phase will begin this summer. The Design Phase will begin in the Spring of 2012, following the completion of site selection and site acquisition phases. Construction of the new 26 department courthouse is scheduled to begin in the Spring of 2014 and be completed sometime in 2016. At some point in time, the current Court Advisory Group (Judges Jacobson, Cordova and Steffen and Mr. Tozzi and Mrs. Romero-Soles) will be expanded to include community and SCBA members.

There will be much more information for you as the project moves along. A site has not been selected and there has been no discussion about moving it away from downtown. Any speculation at this point in time would be premature.

KIOSKS AROUND THE COUNTY

The court with the cooperation of various cities has installed information kiosks in Turlock, Oakdale, Patterson, and the County-City Admin building. A person can use the kiosk to a) look up a pending case, b) pay a traffic citation, and c) check a case disposition. It's a very convenient way to deliver limited services for persons who live a long way from downtown and those without courthouse internet access.

LANDLORD-TENANT/SMALL CLAIMS CLINIC

The Court, in collaboration with CRLA, received a partnership grant award from the State Bar Association last year to form a Landlord-Tenant/Small Claims Clinic for assistance to self-represented litigants. The Clinic is relocating to City Towers on the 6th floor.
