### 3.1.1. Phase In Planning Requirements

A Sec-Ops phase in check lists covers all items required to successfully start or transition a security contract. Our proven checklist must be completed to ensure success of any contract and are typically completed in less than 30 days from award. Upon notification of award, a Project Master Schedule would be specifically tailored and shared for a contract/task order issued by our new client.

Our transition checklist is a part of the Sec-Ops Project Planning and Control System that is used as a part of our established set of iterative processes from which plans are generated and information is distributed to managers. Development of plans is accomplished by defining and authorizing work, establishing budget and schedule base lines. Generation of feedback, which assists managers in controlling projects by allowing them to anticipate, rather than merely react to problems, is accomplished by accumulating data, analyzing, and measuring performance, formulating corrective action plans, and making necessary changes to work scope, schedules, and budgets.

### 3.2. Personnel Qualifications

Candidates for employment will meet all requirements presented by the client. All candidates for employment on this program will be U.S. citizens and at least 21 years old, have a high school diploma or GED, and able to safely follow procedures and properly use security equipment. Furthermore, we will ensure that guards speak, read, and write English fluently, and are able to understand, explain, interpret, and apply rules and regulations. In addition to these requirements, all candidates will have at least one of the following experience or education qualifications: one year of security experience, three years of military/National Guard experience, successfully completion of a state certified Police Officer's Standard Training academy or federal law enforcement academy, or a combination of experience and education.

During the screening process, we also conduct an extensive credit and criminal history check to ensure that candidates have good financial standing and have no previous arrests or convictions. We also contact candidate references to verify that candidates have the demeanor and competence necessary to complete the work required under the Statement of Work. Furthermore, we ensure that all commissioned candidates comply with the Lautenberg Amendment in order to serve as a commissioned officer should the need arise. ## 3.3. Training

Training is a critical element in ensuring that the contractor's employees have the skills and qualifications to carry out their duties. All Sec-Ops personnel employed are or will be qualified and certified in accordance with the contract requirements and our training academy standards. It is important to note that all such personnel employed under this contract will remain certified throughout the contract term as our continuing education program maintains all certifications. In
