ABOUT THE WALK

Join us in our effort to raise support and awareness for the women 18-25 years of age, aging out of foster care and/or have been trafficked.

The one (1) mile walk will take place October 16th, 9-11 a.m., Downtown Newark at the square. You are welcome to walk in person, individually or with a team you form, that day or on your own, anytime, any place. Through social media and our website we will keep track real time of donations and the leader board. Through the Facebook Event and on the website we will post information, testimonies, special guests, encouragement and updates.

OUR GOAL

Our goal is \$50,000 to provide housing for our young women that will soon be living at the Strong Tower home. Your goal is to raise \$200 or more! Every \$200 pays for approximately one week of living expenses for one young lady. Sponsors can give online (preferred), by check or cash and you will then bring to the walk or mail to us. How many weeks and how many ladies will we be able to keep safe and help?

Walkers that raise \$200 will receive the custom Kingdom Pillars cinch bag and other free stuff! You can reach the goal by asking 10 people to give you \$20 each! There are additional gifts at the \$400, \$600 and \$800 levels as our way of thanking you for walking and raising support to help us.

2020 CARES Act & Coronavirus Response & Relief Supplemental Appropriations Act, 2021

Extended Tax Deductions for 2021 Makes it Easier to Give

The universal deduction for charitable contributions has been extended to include gifts made in 2021.

Without itemizing, an individual may deduct up to \$300 (\$600 for a married couple) in annual charitable contributions in 2021.

Those itemizing in 2021, may deduct contributions up to 100% of their adjusted gross income.

Corporations may increase giving to 25% of their taxable income.

Your donors will want to consult with their tax preparer for specific details, such as:

- Contributions made by cash, check, credit card to a 501(c)3 tax-exempt organization qualify. Property, clothing/goods, and stocks do not qualify.)
- Contributions made since January 1, 2021 may be counted toward the \$300 cap. (Donations to a donor-advised fund (DAF), and some other select funds/foundations do not qualify for the deduction.)
- Taxpayers will list it as an adjustment to income on Schedule 1 of Form 1040, and then deduct it from their gross income (along with any/all other adjustments to income) on the first page of their 1040.

Great News for Major Gifts

Itemizers may deduct contributions up to 100% of their Adjusted Gross Income (AGI). For example, if someone's AGI is \$100,000, they may deduct \$100,000 in charitable contributions and wipe out their income tax liability entirely.

Donors who use this provision must tell the IRS. Any contributions in excess of total AGI may be carried forward for up to five additional years

Corporations

Usually giving is limited to 10% of taxable income for the corporation. That limit has been increased to 25% of the taxable income, making charitable gifts much more attractive to business donations.
