## Terms

### Non-refundable Deposit Information

I understand that I must pay the NON- REFUNDABLE deposit in order to secure my requested date.

I understand that my date is not booked until I submit the form, this contract, and the deposit.

I understand that my deposit is deducted from the total amount due on the date of the wedding, covering the cost of my bridal trial(s) and my day-of bridal services.

I understand that my deposit is non-refundable for any reason other than a cancellation of services by the Servicer due to health or personal reasons.

I understand that the Servicer will attempt to find experienced, talented, and comparable coverage in the event that the Servicer cannot complete the services booked by the Customer. The Servicer will then either transfer the deposit to the new Servicer or refund the deposit to the Customer.

I understand that if I choose to delay, postpone or reschedule my event due to the current pandemic to a date/time that the Servicer(s) is not available, with or without consulting the Servicer(s), my deposit will NOT be refunded.

I understand that if I choose to cancel my event and services outright due to the pandemic or for any reason, my deposit will NOT be refunded.

### **Balance Payment Information**

I understand that the total amount due for my entire wedding party, including any additional fees to the bride, is due in ONE lump payment 2 WEEKS before my wedding date.

The balance must be paid via the Square Invoice. This invoice includes a small square processing fee charged by the Square payment platform.

### **Requested Services Information**

I understand that I may not cancel ANY services for the event after 90 days prior to the event date.

I understand that I will be charged and responsible for payment of the amount agreed upon at the time of booking, even if the number of services has declined since booking within 90 days of the event.

I understand that I am able to add on services up until 2 weeks before the event date.

### **Potential Additional Fees**

I understand that I will be charged an additional \$25 fee for all Servicers needed to perform the requested services for events that fall on Holidays or Holiday weekends.

I understand that I may be charged a travel & on-location fee for all Servicers needed to perform the requested services on the date of the wedding at the location requested.

I understand that I will be charged an additional \$50 on-location fee per Servicer for bridal or event parties that are under 5 people total and further than 20 miles from the Servicer(s).

I understand that I will be required to pay an additional \$50 "Early Start Fee" per Servicer for wedding day start times earlier than 7:30 am EST. This includes moving your start time before 7:30 am after a later timeframe was already agreed upon.

I understand that if I change my agreed-upon wedding day timeframe to a shorter timespan, thence requiring a second artist, I will be charged a travel fee for this artist as well as a \$100 "Second Artist Fee".

I understand that I will be charged a travel fee AND an on-location fee if I do not receive my trial and/or wedding day services at Servicer's studio or salon.

I understand that I am responsible for payment and/or reimbursement for all parking fees or valet fees for all Servicers who drive to the requested location on the date of the wedding.

### **Force Majeure**

I understand that this agreement of services and contract may be terminated at any time by the Servicer without refund of the deposit due to acts of God, pandemic including COVID-19, acts of state or governmental authorities, local lockdown or shut down, natural catastrophe, fire, storm, flood, earthquake, riot or civil disturbance, power failure, or any other situation out of the control of the Servicer, excepting personal or health issues not related to the current pandemic.
