This contract is between Coco Miletti, Makeup Artistry & Styling (the "Business") and Coco Hall-Test (the "Client") dated 11/10/2023.

Terms

Non-refundable Retainer Information

I understand that I must pay the NON- REFUNDABLE retainer in order to secure my requested date.

I understand that my date is not booked until I submit the questionnaire (<https://form.jotform.com/220460592245048>), this contract, and the retainer.

I understand that my retainer is deducted from the total amount due on the date of the wedding, covering the cost of my bridal preview and my day-of bridal services.

I understand that my retainer is non-refundable for any reason other than a cancellation of services by the Servicer due to health or personal reasons.

I understand that the Servicer will attempt to find experienced, talented, and comparable coverage in the event that the Servicer cannot complete the services booked by the Customer. The Servicer will then either transfer the retainer to the new Servicer or refund the retainer to

the Customer.

I understand that if I choose to delay, postpone or reschedule my event due to the current pandemic to a date/time that the Servicer(s) is not available, with or without consulting the Servicer(s), my retainer will NOT be refunded.

I understand that if I choose to cancel my event and services outright due to the pandemic or for any reason, my retainer will NOT be refunded.

Balance Payment Information

I understand that the total amount due for my entire wedding party, including any additional fees to the bride, is due in ONE lump payment 2 weeks before the Customer's wedding date.

The balance must be paid via the Square Invoice. Your invoice will also include the Ohio sales tax calculated on the requested services.

Requested Services Information

I understand that I may not cancel ANY services for the event after 6 months prior to the event date.

I understand that I will be charged and responsible for payment of the amount agreed upon at the time of booking, even if the number of services has declined since booking within 6 months of the event. It is suggested that you attempt to find replacements for the services.

I understand that I am able to add on services up until the day before the event date, given that the new number of services does not exceed the abilities of the scheduled Servicer(s) within the scheduled timeframe.

Potential Additional Fees

I understand that I will be charged an additional \$35 fee for all Servicers needed to perform the requested services for events that fall on Holidays or Holiday weekends.

I understand that I may be charged a travel & on-location fee for all Servicers needed to perform the requested services on the date of the wedding at the location requested.

I understand that I will be required to pay an additional \$75 "Early Start Fee" per Servicer for wedding day start times earlier than 7:00 am EST. This includes moving your start time before 7:00 am after a later timeframe was already agreed upon.

I understand that if I change my agreed-upon wedding day timeframe to a shorter timespan, thence requiring a second artist, I will be charged a travel fee for this artist as well as a \$100 "Second Artist Fee".

I understand that I will be charged a \$150 fee if a scheduled Second Artist will no longer be needed, or canceled, due to the total amount of services declining.

I understand that I will be charged a travel fee AND an on-location fee if I do not receive my trial and/or wedding day services at Servicer’s studio or salon.

I understand that I am responsible for payment and/or reimbursement for all parking fees or valet fees for all Servicers who drive to the requested location on the date of the wedding.

Force Majeure
