Make sure to include: Where? When? What are they doing? How Many? What are they carrying? Take pictures and video if possible. Operators can talk you through information if you are approached while doing so. Indy Rapid Response can not offer legal advice, but we can support callers by reminding them of their rights when encountering ICE or Police, and connecting them with local resources if they or a loved one is detained. #### MISSION:

Indiana AID (Assistance to Immigrants in Detention) is a volunteer group that supports individuals detained by ICE in Indiana by bearing witness to their experiences through visits, offering information, and providing resources to them and their families. We have a group that travels to the Clay County jail once per month for spiritual care, as well as a virtual visitation program through which we offer to pair every immigrant who arrives there with a visitation partner. We also facilitate connections between immigrants and various service providers in our region, provide commissary support so that the people can buy food and medicine, and offer general updates to the public about developments in immigration detention in our state.


#### Future Goals for Indiana AID:

- Indiana AID local coordinators for each major city and town in Indiana whom we can contact as needs arise.
- Seeing an end to punitive detention for immigration in the state of Indiana.



## What is a warrant?

There are several types of warrants, and it is important to know what type of warrant you are being presented because not all warrants give the same access to your private space. There are three types of warrants to learn about: an arrest warrant, a search warrant, and an administrative warrant.

A **judicial arrest warrant**, signed by a federal or state judge, is generally based on criminal charges filed against you but does not give authority to enter a home unless you are in your home.

### [JPG Judicial Arrest Warrant](#)

A **judicial search warrant**, it is signed by a federal or state judge, gives law enforcement authority to enter a private space, like your home, to ask questions and inspect the area. Law enforcement is only able to search the location that is identified in the warrant.

### [JPG Judicial Search Warrant](#)

An **administrative warrant**, or ICE Warrant, is signed by ICE officials themselves, never by a judge. This type of warrant gives federal immigration officials permission to arrest someone for civil immigration purposes, **BUT NOT** the right to enter your private space or search it. You **DO NOT** need to let ICE in.

### [JPG Administrative Warrant](#)

If ICE agents show you an administrative warrant but they force their way in, say **you don't consent**, but don't try to stop them.

And don't answer any questions. **Remember, in any encounter with ICE or other federal immigration officers, you always have the right to remain silent.**

It is important to remember that even if the law enforcement agency has any of these warrants, you still have the right to remain silent. These warrants will always be in English, but you have a right to, if you live in a Spanish speaking household, to have a Spanish speaking federal official speak to you in Spanish.

\*\*\*\* If ICE knocks on your front door, don't open it, and ask to see a warrant. \*\*\*\*

Agents may show you a judicial warrant issued by a court. Or they might have an administrative warrant from the U.S. Department of Homeland Security.

**There's a critical difference between the two.**

To enter and search your house or non-public areas of a business—like a restaurant kitchen—ICE needs a valid judicial warrant issued by a court and signed by a judge, like the one below.

Here's what to look for:


- At the top, it says Superior Court of Indiana or U.S. District Court.
- Make sure the address is correct, and the person named on the warrant lives at the home.
- Check the date and signature.




You're Invited!

This hybrid event will be offered both in-person in downtown Indianapolis and virtually at the same time. Please register to receive the address/Zoom link. Register via QR below.







