

**Chase Creek Swim Club  
Waiver and Release of Liability Form**

I, on behalf of myself and all household members under 18 years of age for whom I am a parent or legal guardian, do hereby waive and discharge Chase Creek Swim Club, its directors, officers, employees, and agents from liability for any and all claims and damages, including those caused by the negligence of Chase Creek Swim Club, resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in swimming activities, use of facilities, premises, or equipment.

I understand that Chase Creek Swim Club does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance, in the event of injury, illness, death or property damage. I also understand that my time with Chase Creek Swim Club may include activities that may be hazardous to me. Swimming and physical activity, by its very nature, carry with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from minor injuries such as scratches, bruises, and sprains to catastrophic injuries resulting in paralysis or death. I know, understand, and appreciate that these and other risks are inherent in the activities made possible by Chase Creek Swim Club. I hereby assert that my participation and the participation of minors listed on my membership in such activities is voluntary, and that I knowingly assume all such risks.

I acknowledge that I have been provided with the CCSC Pool Rules. I agree that I, and any guests or minor children for whom I am the parent or guardian, will fully comply with all such Rules and with all signage posted at the pool.

I have read this Waiver and Release of Liability, fully understand its terms, and understand I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily and intend it to be a complete and unconditional waiver and release of all liability to the greatest extent allowed by law. I expressly agree that this Waiver and Release is intended to be as broad and inclusive as permitted by the laws of the State of Maryland, and that this Waiver and Release shall be governed by and interpreted in accordance with such laws. If any portion of this release shall be deemed by a court of competent jurisdiction to be invalid, such invalid portion shall be severed and the remainder of this release shall remain in full force and effect. This release cannot be modified except by writing signed by you and the Chase Creek Swim Club.

You voluntarily agree to assume the risk of contracting COVID-19 at the Chase Creek Swim Club, including as a consequence of the actions of the Chase Creek Swim Club, its staff or its other members and families. You accept sole responsibility for any resulting injury to yourself, your spouse or partner, and any/or any children in your care, as well as any illness, damages, loss, claim, liability or expense of any kind (each a "Claim") that you, your spouse or partner, or such children may experience or incur in connection with the risk of transmission of COVID-19.

On behalf of yourself, and any children in your care, you hereby release, covenant not to sue, discharge and hold harmless the Chase Creek Swim Club, its owners, officers, employees, agents, contractors, vendors, or, representatives, of and from the Claims, including all actions, damages, costs or expenses of any kind arising out of or relating thereto. You understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Chase Creek Swim Club, its owners, officers, employees, agents, contractors, vendors, or representatives. If any portion of this release shall be deemed by a court of competent jurisdiction to be invalid, such invalid portion shall be severed and the remainder of this release shall remain in full force and effect.
