

Chase Creek Swim Club Rules



May 7, 2021

Note that these rules are in effect as of May 6, 2021. We are following current local, state and federal guidelines regarding Covid-19. These rules are rapidly changing and the Chase Creek Swim Club (CCSC) Board of Directors will update rules accordingly and in alignment with the Anne Arundel County Health Department. Changes in the rules will be communicated via email, the CCSC facebook page and website, and will be posted at the pool.

Policies for Entering and Leaving the Facility

- 1) Anyone entering the gated pool grounds must be covered by a signed *Waiver and Release of Liability Form*, which in 2021 also includes a COVID-19 waiver.
- 2) Members entering the pool grounds must follow the designated sign in process. If the check in process/person cannot confirm membership, then that individual will not be permitted to enter.
- 3) All guests must also be covered by a signed *Waiver and Release of Liability Form* as well as a Covid-19 Waiver. It is the member's duty to inform their guest(s) of the CCSC Pool Rules.
- 4) If you are sick or feel sick, you should remain home.
- 5) Participation at CCSC is only allowed if you have had no signs or symptoms of COVID-19 and you have not been exposed to someone who has had signs or symptoms of COVID-19. If you have had a positive test or exhibit signs of COVID-19, you should contact the Health Department 410-222-7095 or 443-481-3140.
- 6) No more than 100 people can be in the pool at one time, and no more than 250 people can enter the CCSC grounds at one time. Access to the pool will be provided on a first come – first serve basis until the designated capacity has been reached. We trust that our members will be courteous and ensure others can have equal opportunity to enjoy time in the pool.
- 7) Unless designated by the CCSC Board of Directors, no one is permitted on pool property before or after operating hours; swim team and swim clinics are an exception and allowed admittance during designated times.

Current Social Distancing and Cleaning Policies

- 1) Everyone age two or older must wear a face covering when in the restrooms.
- 2) Everyone must maintain six feet social distance from non-household members while on the deck and in the water.
- 3) Members should frequently wash their hands with soap and water or use hand sanitizer. A sanitization station is provided near the entrance to the pool.
- 4) The onus to adhere to these requirements is on families. Please consider and respect that your risk tolerance may be different than that of other pool members. Lifeguards are primarily responsible for ensuring the safety of people in the water and are not responsible for enforcing social distancing.
- 5) The bathrooms will be thoroughly cleaned and sanitized at least twice a day.
- 6) A sanitization station with cleaning products will be provided for members to clean common tables and furniture before and after use.
- 7) Please use the tables and pool furniture based on your own comfort level. Members/families are allowed to bring their own furniture if they prefer to use this instead of the CCSC furniture.

Pool Safety and Courtesy

- 1) Members who witness any physical violence, destruction of property, profane language, or behavioral issues should report the incident to a lifeguard immediately.
- 2) Lifeguards are authorized to enforce all pool rules and remedy ANY situation they feel compromises the safety of pool members. Members are required to respond to lifeguard instructions.
- 3) Noodles, rafts, etc. will be allowed if used in a safe manner and at lifeguards' discretion.
- 4) Parent/Guardian must accompany a non-swimmer in the water within arm's reach at all times.
- 5) Pushing, wrestling, unsafe conduct, dangerous behavior or putting others at risk will not be permitted on the CCSC grounds or in the pool.
- 6) Running is not permitted on the pool deck.
- 7) Children under 13 years old may not be left unattended at the pool (except when participating in organized swim clinics).
- 8) No diving into the pool except off the diving board.
- 9) Only one person is allowed on the diving board at a time. Members wanting to use the diving board must wait on the deck until the person in the water reaches the ladder.
- 10) The lap lane is for lap swimming only.
- 11) Swim diapers must be worn in the wading pool and main pool for those not potty trained.
- 12) No glass of any kind is permitted. All beverages or food brought into the pool area must be in paper, plastic or aluminum containers and be consumed in designated areas. Grills must be turned off, cleaned and covered half an hour prior to closing. If you are the last to use the grill, please clean off the grill and replace the cover.
- 13) Parents or guardians are responsible for the supervision of their children. This includes pavilion and sport court areas. The lifeguards' primary responsibility is the safety and security of the pool area.
- 14) All sand must be washed off prior to re-entering the pool as the pool pump cannot tolerate sand.
- 15) Please clean up after yourself. All trash must be disposed of in a trash container, and tables cleaned off for the next user.

Parking

- 1) Please do not double park in the upper lot. Emergency vehicles need clear access at all times.
- 2) Please note the yellow lines on the driveway entrance and do not park in this area. These are to ensure emergency vehicles have clear access from the street to the upper parking lot.
- 3) Please do not park between the signs on the driveway heading to the pool's main lot as this blocks the private driveway.

Membership

- 1) Membership and pool access is a privilege. The CCSC reserves the right to rescind membership for major or continued rule infraction at any time with no refund.
- 2) There is zero tolerance for unsafe conduct (to self and others), destruction of property, littering, unpaid or unregistered guests, and continued pattern of disregarding the rules. These actions can result in loss of membership.
- 3) Misrepresentation of family members or misuse of membership cards will result in termination of CCSC membership without refund.
