#### Education

#### Activities during this period:

CGNA Education team was formed post May 2023 AGM. The first meeting was held over Zoom in September 2023 after the summer vacation period. Team consisted of 4 team members – self-selected to be members of the team:

Roslyn M Compton Director of Education – Saskatchewan Abigail Wickson-Griffiths – Saskatchewan Barbara Tallman – Manitoba Debbie Lashbrooke – Ontario

Meeting scheduled to begin every 2<sup>nd</sup> month starting October 2023 (November, 2023, January 2024, March 2024, with future meetings booked May, September, November 2024). New members joined the team in November 2023:

Lorie Schindel Martin – Ontario Winnie Sun – Ontario Mariana Ribeiro – Saskatchewan

November 2023 – Feed Your Mind (FYM) was created –an opportunity for CGNA members to come together and learn on topics identified by members in collaboration with experts in the field. Through ongoing conversations, FYM was placed on hold to pursue a partnership with Pallium Canada ECHO series. Jonathan and Holly from Pallium presented to the CGNA Education team. From this conversation, further conversations pursued between Pallium Canada and CGNA Board members. February 2024 a MOU was signed between CGNA and Pallium Canada with the first ECHO session scheduled for April 4, 2024 (Altered Responses).

ECHO sessions have been designed to maximize opportunities for nurses to attend during break times at work -2 30-minute sessions on the 1<sup>st</sup> and 2<sup>nd</sup> Thursday of the month. The first session is a presentation of the concept, and the second session is an application session with the opportunity for case presentations and discussion facilitated by the presenter.

Schedule for Pallium/CGNA ECHO series:

April 4 and 11, 2024 – Altered Responses (Erin Yakiwchuk and Deb Schick) June 6 and 13, 2024 – Family integration into care teams (Sharon Anderson and Jasneet Parmar) September 5 and 12, 2024 – Extracellular vesicles in longevity research (Ayesha Saleem) November 7 and 14, 2024 – Palliative Oral Care (Heather Woodbeck) December 2023 - Roslyn met with Heather Woodbeck and Cathy Schoales to explore learning opportunities and best practices in long-term care. Connections were shared and partnerships were established to share knowledge and resources to engage nurses in the field of gerontology.



January 2024 – Shell created for CGNA Education page on the website. The education team is planning to address the plan for the development of the web page at the May 2024 meeting. February 2024 – Julie and Roslyn met with Jillian McConnell from BrainXchange to explore opportunities to collaborate on building learning and engagement opportunities for nurses caring with older adults. Conversations are ongoing with potential collaborations and linking out to site from CGNA education web page.

- Representatives share the news from their associations at each meeting
- In relation to the function of the committee to provide advice to the Perspectives Editorial Team,

the following advice was put forward:

- 1) To develop a statement to nursing students inviting them to submit manuscripts to Perspectives (Brandy Stadnyk). This action was carried out by Dawn Prentice and Jasmine Hwang who completed the call for manuscripts aimed at nursing students.
- 2) To develop a feature in *Perspectives* that highlights the clinical expertise of gerontological nursing in Canada (Carla Wells). This action was carried out by Lorna Guse, and the first feature will be published in 2024.
- The Terms of Reference of the Committee were reviewed with no changes from the 2022 Version.



The purpose of the *Perspectives* Advisory Committee is to support the work of the *Perspectives* Editorial Team in their mandate to publish original manuscripts describing issues, research and clinical, educational or administrative innovations of interest to gerontological nurses and others who provide care to older adults.

## 1. Goals

*Perspectives* is the Journal of the Canadian Gerontological Nursing Association whose mission is to address the health concerns of older Canadians and the nurses who participate with them in health care. The goal of the Advisory Committee is to contribute innovative approaches to promote *Perspectives* as the national journal of CGNA.

## 2. Functions

- Provide a communication link between the Editorial Team and the conjoint provincial/territorial organizations
- Encourage members of conjoint provincial/territorial organizations and non-conjoint members to volunteer as reviewers and submit their manuscripts to *Perspectives*
- Provide advice to the Editorial Team
- Act as reviewers as requested by the Editorial Team

## 3. Accountability

The Advisory Committee is accountable to the Editorial Team.

## 4. Membership

- Must be a member of CGNA in good standing
- Each conjoint provincial/territorial organization will have one representative (the provincial/territorial President or designate). In provinces/territories where there are no conjoint provincial/territorial organizations in place, through CGNA Office, provincial/territorial CGNA members will be asked to elect a representative from their ranks.
- The Chair, Past Editor of *Perspectives*, will be appointed by Executive
- The Editor-in-Chief, *Perspectives* and CGNA Communication Director will be ex officio members
- Members shall serve a term of three years with an opportunity to serve a second term

## 5. Records

Terms of reference, agenda, minutes and material considered at all Advisory Committee meetings will be collated electronically and distributed by the Chair. Copies will be archived through the main CGNA business office.

## 6. Administration and Finances

• Administrative support is provided by CGNA

- Financial support is provided through membership fees, advertising in the journal and ProQuest royalties.
- Financial expenses for a gathering at the biennial conferences will acknowledge the Editorial Team, Advisory Committee, reviewers and authors.

## 7. Decision Making

Decision-making will occur by consensus, reflecting the values and principles of *Perspectives* and CGNA.

## 8. Terms of Reference

Terms of Reference will be reviewed annually prior to the CGNA Annual General Meeting.

## 9. Meetings

Meetings will be held twice a year (just prior to the CGNA Annual General Meeting and six months later) or at the call of the Chair or any member. Meetings should not normally exceed four per year. Meetings are by video or audio conference.

Name and Position: Kelly Baskerville, President

## Activities during this period:

Board meetings were held in 2023 on June 13th, August 10th, November 8th, and in 2024 on February 5th. We held our AGM on July 18<sup>th</sup>. We have been fortunate to fill most all board positions and thank everyone, particularly those who are finishing their term.

Memberships decreased this year, as we normally see in a non-conference year. That said, we have been able to maintain one of the stronger memberships in Canada, and have seen steady recruitment as our Chapter and Provincial teams have re-initiated in-person events and worked to build relationships in our community of practice.

Our Education committee was very active and collaborated with Chapters to host both virtual and in-person events. We hosted our first in-person Education Day in several years, held in September 2023 in Red Deer. We celebrated an overdue anniversary, as we reached our 40<sup>th</sup> year in 2021, and recognized two new honorary members, Andy LeBlanc and Jennifer Boone.

Online sessions were recorded and available for on-demand viewing by members.

A significant success was the launch of a series of Gerontological Nursing education modules during the first week of January. The modules, gifted to AGNA, were developed by a research team led by Dr. Sherry Dahlke at the University of Alberta, which includes several AGNA members and past board members. The modules aim to provide knowledge about aging and older people to practicing and student nurses. Tested with positive feedback, the modules were part of an Awakening Canadians to Ageism research grant. The modules, containing games, videos, quizzes, and case studies, are free to members and non-members – another testament to AGNA's commitment to lifelong learning and skill advancement. Dr. Dahlke, AGNA President Kelly, and Education Lead Cherryll submitted an article to Canadian Nurse about nursing education addressing ageism through digital access and professional associations. We eagerly await confirmation of a publication date. We encourage anyone to access the learning at <u>www.courses.agna.ca</u>.

In January, we presented to the Alberta Health Service (AHS) Nursing Mentorship network, *How to build nursing leadership, learning and your support network: Making the most of professional associations.* This presentation discussed professional organizations' support nurses to pursue professional development and reflective practice, build networks and leadership skills, and find opportunities to mentor others.

We continue to offer AGNA Continuing Education Awards, with our application period in spring 2024.

We initiated a project to feature our honorary members on our AGNA Website. This project has been inspirational and pays tribute to our members who have served AGNA over the years and inspired Alberta Gerontological Nurses with their devotion, commitment, and passion to advance the practice of Gerontological Nursing in Alberta.

We collaborate with the Alberta Association on Gerontology (AAG), as a member of the AAG Stakeholder Collaborative Committee, in which we regularly work with government, provider organizations, social service organizations, educators, and represent the perspective of gerontological nurses.

Our Communications committee represented AGNA as an exhibitor both virtually and in person at the Healthy Aging Alberta Summit in October in Calgary, and had a representative at the private policy planning consultation session. The Communications Co-Leads have revitalized our presence with members, releasing a newsletter every 2 months, managing our website blog, social media accounts, managing our Zoom account and member emails.

We were pleased to have formed a relationship with the Alberta Association of Nurses and attend quarterly meetings for specialty interest/practice groups.

- December 6, 2023 "A dementia-friendly environment quality improvement project" presented virtually by Martha Neguse, RN, BN, MN, GNC(C) and Carol Truong, RT.
- February 22, 2024 "Understanding dementia" presented in person by Lori Randall, RPN, BScPN at the Faculty of Nursing, University of Calgary.

The Calgary chapter of AGNA continues to offer study groups for gerontological nurses. An information session was offered in January but had only a few attendees. Several people expressed interest later in the year, so study resources were shared with an invitation to one-on-one mentorship. The Chapter supports members' gerontological competency through financial

incentives, including reimbursement for the initial certification and successful certification renewal.

## Edmonton:

Our Edmonton Chapter recruited a few new board members, and was able to support two events; one virtual and one in person.

- November webinar featuring the AHS Behavioral Safety Program, which featured the Clinical Practice standard for identifying and communicating the safety risks and safe care strategies for patients who may display harassing or violent behaviours.
- Dr. Gail Low and her research team presented their innovative project –"Living After Social Distancing—A Study of Older Canadians." This project studied the effects of the pandemic on the mental health of older adults, and resulted in a one-of-a-kind resource to help seniors manage mental health and improve nutrition through an electronic booklet called 'Cooking up Calm.'

Longtime member and a past provincial board member, Jennifer Boone, was recognized as an Honorary Member for her contributions to AGNA and the Edmonton Chapter.

## **Red Deer:**

The Red Deer Chapter was excited to take a leading role in planning and to play host to the AGNA Education Day in September 2023.

## **Current issues facing the provincial Gerontological Nursing Association:**

4. CNA Study sessions: GNABC Education Chair Jade Sol continued organizing CNA certification study session series – 6 webinars in the fall 2023 and spring 2024. Attendance has been great with 15-20 participants in all sessions.



5. Joanne Brown, GNABC Membership Chair continued to produce the GNABC newsletter with stories, events, and reminders for members around the province. Nicole Percival partners with Joanne in producing this really successful newsletter.

6. Gero-Nurses: Tales from the Front Podcast: nine episodes have been shared across streaming platforms with over 650 downloads. The podcast is a collaboration of GNABC and the Centre for Education and Research on Ageing at the University of the Fraser Valley. Guests included gerontology nurses working in a variety of settings including LTC, acute care, research, and education. Gero-Nurses is available on all the major streaming services including Podbean and Spotify.

7. Board Directors: At our 2024 AGM several board members will finish their terms. I will be moving to the Past-President role with Mariko Sakamoto assuming the role of GNABC President. We will be trialing a Communications Chair that will replace our current Media and Membership chairs.

- Targeted membership recruitment strategies will be implemented
