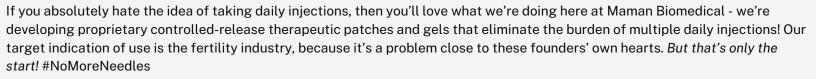

We will compete with 9 other very strong contenders over 2 days of pitching in Toronto and Vancouver for the chance to claim up to \$30,000 in prizes.





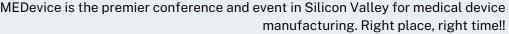
2025 TEAM

REFLECTIONS & LESSONS LEARNED

We spent 2 weeks in Silicon Valley this month. Did it break our banks? Yes. Was it worth it? We'll let the ROI speak for itself!

- 12 days, 2 executives, \$13,000
- 26 startups, 27 founders -> 27 peer-to-peer founder relationships & founder networks
- 19 Speakers -> 19 contacts for doing business in Silicon Valley
- 12 curated one-on-one investor/mentor meetings -> Silicon Valley network
- 2 dedicated networking days with 43 potential investors and strategics -> 1 potential angel, and 1 accelerator expressing interest in onboarding Maman
- 2-day manufacturing expo, 1 international conference stage pitch -> 1 site tour & 1 manufacturing partnership confirmed!

This trip was part of a long game. A high-risk gamble to jumpstart critical discussions for our upcoming \$1.5M pre-seed raise. Was it the right decision? That question haunts me every time I look at my cash flow. But I'm not walking this road blind - I'm choosing the path that gets us over the mountain fastest, even if it's the scariest or toughest to climb!

- I'd love to say we're gonna take some much-needed family time over the holidays to rest up and recharge for the new year. Instead, we're gonna be taking advantage of the quiet time to catch up on some internal housekeeping!
