This contract is between Country Roads Boarding Kennels (CRBK) and the pet owner whose signature appears on said contract.

- 1) I (The Owner) agree to pay the rate for boarding in effect on the date the pet(s) are checked into the CRBK facility. I further agree that my pet(s) shall not leave the CRBK facility until all outstanding charges are paid to CRBK by the Owner. I certify to the accuracy of all information provided by me about said pet(s). I specifically represent that I am the sole owner of the pet(s), free and clear of liens and encumbrances.
- 2) I represent to CRBK that my pet(s) have not been exposed to rabies, distemper or Canine Influenza within a 30 day period prior to boarding and is/are current on all required vaccinations: Rabies, Distemper, Bordetella and Canine Influenza. For the safety of all animals, CRBK cannot care for pets that are not up to date on these vaccinations.
- 3) External parasites: CRBK is a "Flea and Tick Free" facility. I acknowledge that any pet admitted by me that has live fleas and/or ticks will be treated to a flea bath and a topical dose of flea and tick prevention at my expense.
- 4) Veterinarian's Release: If any pet belonging to me becomes ill, CRBK is authorized to transport them to the veterinarian of record and/or the closest emergency veterinarian hospital at my expense. The veterinarian is to call me for permission to treat. If I am unavailable and my pet's condition is deemed an emergency, the veterinarian is hereby authorized to treat the pet at his/her discretion. I agree to pay the veterinarian's fees for all emergency treatments and will not hold CRBK responsible for any charges incurred.
- 5) Cancellation policy: I understand that if I fail to cancel my boarding reservation without 72 hours notice I will be charged for a full day's boarding. I also understand that if I fail to cancel my boarding reservation over a holiday weekend within 72 hours, I will be charged for two full days of boarding.
- 6) Abandoned Pets: I agree that I will pick up my pet(s) by the time scheduled unless I provide notification of extended stay requirement. I understand that if I abandon my pet(s) CRBK, by default, will become the legal owner and relinquish the pet(s) to a guardian/shelter of their choosing. "Abandoned Pet" is defined as, "a pet left with Country Roads Boarding Kennels for five days longer than the scheduled stay with no explanation or contact from its owner".
- 7) Aggressive Pets: Due to the open/free play policy of Country Roads Boarding, aggressive pets are not accepted. I understand that if my pet(s) act aggressively they will be separated from other pets for the remainder of their stay and will be asked not to return to CRBK.
- 8) Waiver of Liability/Assumption of Risk: As a pet owner leaving my pet at CRBK I recognize that there are certain risks of injury or illness that are out of the control of CRBK staff. By signing this contract I recognize that there are incumbent and potential risks involved with the interaction between humans and dogs as well as between dogs and other dogs which may result in property damage or bodily injury. I fully accept and assume responsibility for all risks, including, without limitation, all losses, costs and damages incurred as a result of my pet's stay at CRBK, including any veterinarian expenses incurred on behalf of my pet(s).

Note: CRBK will always exercise all reasonable care for boarding pet(s), but very rarely accidents happen and CRBK will always try to exercise the very best judgement when dealing with any health issues that arise.

- 9) Grooming Liability Release: I understand that CRBK will take every precaution to take excellent care of my pet(s). CRBK will not be held responsible for clipper burns, minor nicks, skin irritation, any after-grooming effects for de-matting and clipping procedures or problems uncovered on a badly matted or otherwise neglected pet's coat resulting from grooming. CRBK will not be held responsible for any condition or problem discovered during grooming and is authorized to seek veterinary care if they deem necessary.
