## The 2020 7th District Optimist Club by Richard Lord Updated 9/21/2019

The 7<sup>th</sup> District Optimist Club (Club) shall have a change in leadership for 2020 beginning at the end of September 2019. This shall be a welcome change from the 2019 leadership. I expect the 2020 Club leadership to act with the upmost of integrity and honor.

Consequently, I have updated and upgraded my rating of the 7<sup>th</sup> District Optimist Club on a scale of 1-5 with 5 being the best from a 3 to a 4. The advent of new Club leadership is the basis of the rating change from a 1 to a 4. I would have upgraded my rating to a 5 if it were not for the fact the Club Board of Directors shall consist of many of the same few that have so despoiled the Club. The negativity of these few shall be a challenge to the functionality of new Club leadership. I shall upgrade my rating to a 5 should the new Club leadership exert itself with exceptional veracity; but shall downgrade it back to a 1 should it succumb to the influence of these negative forces.

From my many years with the Club, it has ranged from between 100 to 120 members. Of that number, only about 25% or between 30-40 members are actively engaged in Club activities. Given that most of those who participate in Club activities are long retired, over the next decade, the Club shall lose most of those who actually do the business of the Club.

The Club just lost James "Duffy" Owens. Duffy did much for the Club, was a voice of reason, and shall be greatly missed. Duffy is the first of the beginning of the upcoming great departure of an aging Club membership.

Duffy supported my becoming BOF Chairman in 2015. I became Chairman when Robert Steele Pogue abruptly stepped down as Chairman in a bitter dispute with the Club. I have been told I saved the BOF when I stepped forward volunteering to be Chairman when no one else would.

The Club had better reform itself broadening its membership and improving its climate. This, if it is to continue to exist. This is a case of "Change or Die".
