SPACE/BOOTH DETAILS

Vendor/organization will be provided with minimum 10'x10' exhibit area. Vendor/organization is responsible for providing own tent, table and chairs. Tent, tables & chairs are available for rent and request must be made on the vendor application. No structure may exceed 15' in height. You may provide any tent or booth structure as long as it falls within the City of Sandusky safety guidelines and fits within the space you have rented. YOUR TENT MUST BE WEIGHTED AND SECURED 40 POUNDS PER LEG. Sandusky Pride has final determination over the placement of all vendors within the event space. Please note: outside of load-in/load-out times, you must carry in and carry out any of your supplies. No cars are allowed in event during posted event hours.

POWER

Electricity is available but limited. Please note any electricity needs on application. You may bring your own battery powered equipment. Gas-powered generators are not permitted due to noise and fume emissions.

NOISE

As a courtesy to other exhibitors, Sandusky Pride reserves the right to limit amplified sound from your vendor space.

SPECIAL REQUESTS

All special requests must be included in this application, please add additional paper if necessary. Late requests have no guarantee of accommodation.

CANCELLATIONS

You may cancel your vendor application at any time prior to the stated application deadline of June 1, 2023, and receive a full refund. Cancellations made after the stated deadline will not be refunded.

Sandusky Pride 2023 will be located along the waterfront in Downtown Sandusky, Ohio

Food Vendor fee is \$250 for the event. All vendor fees are nonrefundable. Vendor payment must be received before load-in (Friday, June 25, 2022). Please make checks payable to Sandusky State Theatre.

Food Vendor agrees to supply food at Sandusky Pride on:

Friday, June 23 | 2:00-11:00 pm Saturday, June 24 | Noon-11:00 pm

If you sell thru your food offerings, you may close, but you may not load out until close of event.

Food Vendor agrees to comply with all terms and conditions stated below and made part of this contract.

Food Vendor agrees to upload a logo that will be used for marketing purposes by Sandusky Pride Committee. Food Vendor will not be required to pay any additional marketing fee.

The Sandusky Pride Committee reserves the right to deny any Food Vendor at its discretion. However, if such determination is made after the Food Vendor has paid the registration fee; the Sandusky Pride Committee agrees to return fees to the Food Vendor.

All Food Vendors are individually responsible for collecting sales tax and submitting to proper authorities. Food Vendor agrees to and/or has complied with any and all local, state, federal, or other relevant government jurisdiction's laws regarding, rules and regulations, regarding the sale of merchandise sold by said Food Vendor.

All vendors are responsible for obtaining the proper permits to conduct a trade or business in the City of Sandusky or the State of Ohio and shall display said licenses as required by state and local law at all times Food Vendor's trade or business is open to the public.

All Food Vendors must supply the Sandusky Pride Committee with a Certificate of Liability Insurance for a minimum of \$1,000,000.00. (One million dollars).

All Food Vendors agree to comply with all terms and conditions stated in the Hold Harmless Clause and Liability Waiver included as part of this agreement.

Food Vendors will be provided with a minimum 10 x 10 exhibit area. Food Vendors are responsible for providing their own tent, tables, chairs, extension cords, and water hoses if needed, and other props unless indicated otherwise on this form. Power will be provided through either the city or a shared generator. If power is required by the vendor there will be an additional charge of \$10 per day.

Load-in will begin at 10:00 am on Friday, June 24, 2022. All vehicles must be removed from Food Vendors area no later than 1:00 pm. No exceptions.

Food Vendor is responsible for all labor for and at its location(s), including set-up and tear down at their location.

Food Vendors are asked to keep their area clean of debris.

Food Vendors are responsible for removing unsold merchandise at the close of the event. Food Vendors are required to take reasonable care to avoid damaging City of Sandusky property in setting up and tearing down.

Food Vendors shall not assign, sublease, transfer or share its interest in this contract without the prior written consent of the Sandusky Pride Committee.

The Sandusky Pride Committee reserves the right to determine the exact location of the Food Vendor's trailer/booth at the Sandusky Pride. The Sandusky Pride Committee reserves the right to prohibit the sale of merchandise that does not comply with the terms and conditions of this contract.

Any loss suffered by the Food Vendor is the sole responsibility of the vendor. The Sandusky Pride, Sandusky State Theatre, or the City of Sandusky shall not be held liable or chargeable for any loss of sales, income, resale or commissions of the Food Vendor. This includes revenue loss due to inclement weather conditions.

The Sandusky Pride Committee does not grant category exclusivity to Food Vendor.

NON EXCLUSIVE CLAUSE

Sandusky Pride reserves the right in any given year to determine that NO vendor will have exclusivity on any certain food item. Sandusky Pride strives to provide variety for the event and its guest.

HOLD HARMLESS CLAUSE

To the fullest extent permitted by law, I agree to defend, pay in behalf of, and hold harmless the Sandusky Pride Committee, Sandusky State Theatre, the City of Sandusky, event organizers, volunteers, staff and/or others working on behalf of the Sandusky Pride committee against any and all claims, demands, suits, losses, including all costs connected therewith, for any damage which may be asserted, claimed or recovered against or from the Sandusky Pride, Sandusky State Theatre, the City of Sandusky and/or its committee, volunteers, staff or all others working on behalf of the Sandusky Pride by reason of personal injury, including bodily injury and death, and/or property damage, including loss of use thereof, which arise out of the alleged negligence of my business and/or in any way connected or associated with this contract.

LIABILITY WAIVER

The Sandusky Pride, Sandusky State Theatre, or the City of Sandusky are not responsible for any damage done by a Food Vendor, or by his/her employees or agents, to any person or property. These organizations are not responsible for loss or damage of any materials/equipment caused by patrons/visitors.

Food Vendors shall hold the Sandusky Pride, Sandusky State Theatre, or the City of Sandusky harmless and waive the right of subrogation against the Sandusky Pride, Sandusky State Theatre, or the City of Sandusky. Food Vendors shall carry their own liability insurance and present Certificate of Insurance as part of the reservation process.

The Sandusky Pride, Sandusky State Theatre, or the City of Sandusky assumes no responsibility for accidents to any person, property or loss of damages by theft, fire, water, wind, storm, or acts of third party or for any other causes; and all Food Vendors and their agents agree to abide by all the rules and regulations of the Sandusky Pride and/or its committee, staff, volunteers thereto.

The violation of any of the above-mentioned conditions by a Food Vendor and/or by his/her agents or employees shall annul the contract between contract holder and the Sandusky Pride. I agree to abide by all the rules and regulations of the Sandusky Pride, Sandusky State Theatre, or the City of Sandusky and its committee, staff, volunteers thereto.
