The self-attested declaration along with updated PAN card are enclosed as supporting evidence for your verification.

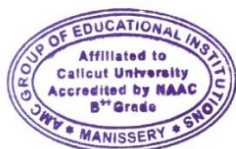
We respectfully request you to kindly consider the above clarification and accept the faculty details accordingly.
