8	Student / Faculty Facilities	A detailed covering letter and the appointment letter of the Student Counsellor are ready for submission.

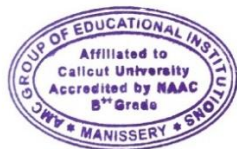
