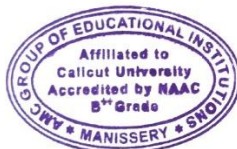
We hereby confirm that the land is in the possession of TRISHA Charitable Trust and is being used for the purposes of the institution in compliance with AICTE norms.
