The parties have set their signature on this document under their office seal.

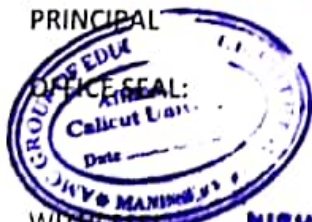
