Subject: Clarification regarding Faculty-Student Ratio – AICTE Approval Process 2026–2027

Respected Sir/Madam,

With reference to the observations in the Expert Visit Committee (EVC) report, we would like to respectfully submit a clarification regarding the faculty-student ratio shown in the report.

As per the EVC report, the faculty-student ratio was reflected as 1:26, and it was also mentioned that the institution is not maintaining the faculty/student ratio as per AICTE norms. The institution respectfully submits that this was due to an oversight in calculation.

On verification of the programme-wise faculty and student data, the correct position is as follows:

Overall position	The institution has appointed 27 faculty members against the required 26. Based on the actual programme-wise data, sufficient faculty are available as per requirement.


We sincerely submit that the earlier ratio of 1:26 was not the correct faculty-student ratio and appears to have been mentioned due to a calculation oversight. The corrected programme-wise statement shows that the institution has adequate faculty strength and is meeting the required faculty position.

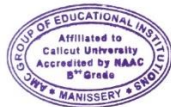
We therefore request you to kindly consider the corrected calculation and update the compliance status accordingly. Supporting calculation sheet is enclosed for verification.
