**ORDER**

Provisional affiliation was granted to start AMC Group of Educational institutions (Unaided), Manissery, Ottappalam, Palakkad under the management TRISHA Charitable Trust, Ottappalam in the academic year 2014-15, with B.Com Finance (30) and BBA (30) programmes, vide University Orders read as (1) and (2).

2. Additional affiliation was granted to B.Com Computer Application (40), B.Com Co-operation (40) and B.A Economics (40) programmes in 2015-16, vide University Order read as (3). Additional affiliation was granted to M.Com (Finance) (15) and BBA-HRM (30) programmes in 2020-21 vide University Order read as (4). Provisional affiliation was granted for starting BA English Language and Literature (24) during the academic year 2021-22 vide University Order read as (5).

3. Permanent increase in seats was granted to B.Com Finance (30 to 45), B.Com Co-operation (40 to 60), B.Com Computer Application (40 to 60), B.A Economics (40 to 60) and BBA Finance (30 to 45), w.e.f 2023-24 vide University Order read as (6). Continuation of provisional affiliation was granted to the aforementioned programmes for the academic year 2023-24, vide University Orders read as (7) and (8), on conditional basis subject to submission of the renewed NOC.

4. The Principal, vide paper read as (9), has applied for continuation of provisional affiliation to these programmes for 2024-25 with renewed NOC for 2023-24 and 2024-25 vide papers read as (10) and (11).

5. Considering the matter, the Vice Chancellor has accorded sanction to

(i) make the orders read as (7) and (8) as absolute and :

(ii) to grant Continuation of Provisional Affiliation to the programmes, as detailed below offered at AMC Group of Educational institutions (Unaided), Manissery, Ottappalam, Palakkad, for the academic year 2024-25, with strict direction to the Principal of the college to engage faculties with qualifications prescribed by the respective regulatory body and in compliance with the provisions of ACT 13 of 2021.

6. Orders are issued accordingly subject to the following terms and conditions :

- Affiliation granted is strictly provisional and only for the academic year 2024-25.
- The Principal shall strictly follow the syllabi available in the University website [www.uoc.ac.in](http://www.uoc.ac.in) for selecting complementary courses.
- The complementary courses/common courses specified in this order are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/ for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
- Selection and admission shall be made only on the basis of the rules and regulations of the University/ Government and on the basis of the directions issued by the University/Government from time to time.
- In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form.
- The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2024-25.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Violation of any of the above will lead to the cancellation of affiliation.
