As per the EVC report, the same was noted as not presented at the time of inspection.

In this regard, we respectfully submit the following details:

Observation	Explanation
Food Safety and Standards Act, 2006 Compliance:	The institution has ensured compliance with the Food Safety and Standards Act, 2006 through a valid registration certificate obtained under FSSAI. The certificate is enclosed for verification.
Canteen Operations:	The canteen facility within the campus is operated on a contractual basis by an external vendor. The responsibility for food safety compliance is maintained by the vendor as per statutory requirements.
FSSAI Certification:	The external vendor operating the canteen (Krishna Stores – Mrs. Raji S Nair) holds a valid Food Safety Registration Certificate issued by the Government of Kerala under FSS Act, 2006.
Collaboration Arrangement:	A formal collaboration arrangement exists with Mrs. Raji (Krishna Stores), who has provided space and is rendering canteen

services for AMC. Supporting documents are enclosed.

Reason for non-presentation:

During the time of inspection, the relevant documents could not be presented due to operational oversight. The same has now been compiled and submitted for verification.


We hereby assure that all food safety norms are duly complied with and maintained as per statutory requirements. The institution remains committed to ensuring hygienic and safe food services within the campus.

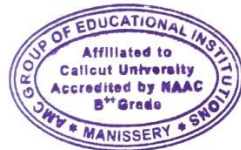

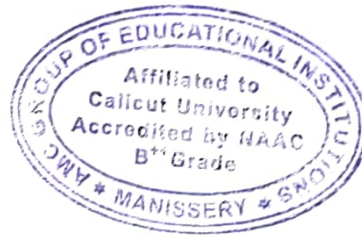
