In view of the recommendation from the University, vide paper read as 3rd & 4th. the Govt. have granted Administrative Sanction and NOC for starting the new unaided/ self-financing Arts and Science college by the name of 'AMC Group of Educational Institutions', Manissery,Ottapalam,Palakkad under AMC Group of Educational Institutions,Trisha Charitable Trust,Manissery with the new Self-financing /Unaided courses of BCom and BBA with an intake of 30 students each during the academic year 2014-15

The Chairman, AMC Group of Educational Institutions under Trisha Charitable Trust, Manissery, Palakkad vide paper read as 5th, has requested to grant affiliation for starting the College for the academic year 2014-15.
