## Tuition Payment Options – 2024-25

**Tuition is an annual fee.** For your convenience, we offer several payment options. You must make your selection at the time of enrollment. Monthly payments and discounts are rounded up to the next dollar amount.

**YOU WILL NOT RECEIVE A MONTHLY INVOICE**

TUITION IS DUE THE 1<sup>ST</sup> DAY OF EACH MONTH

Once you have made your selection, it will apply for the entire school year and cannot be changed at anytime during the year. **If we do not receive your first payment on time according to the plan you choose, you will automatically be placed on the 9 month plan.**

### TUITION – Choose Plan:

- FULL PAYMENT – Due Sept. 1 (3% discount)
- MONTHLY PAYMENT PLAN OPTIONS (please mark one):
  - 12 month Payments June 1, 2024-May 1, 2025
  - 9 month Payments Sept. 1, 2024-May 1, 2025

### CURRICULUM FEE:

**Preschool - \$225**(includes supplies needed\*)

**Kindergarten-High School - \$375** (includes supplies needed\*)

*Due at time of registration unless added into monthly payments. This is non-refundable & due even if change of mind for enrollment.*

- FULL PAYMENT – Due by May 1
- Add into my Monthly Payments\*\*

\*If supplies need replenished for your child it is the parent's responsibility. Items not included are backpacks, lunch boxes and snacks

**REGISTRATION FEE:** \$125 (Continuing Student)/\$150 (New Student)

*Due at time of registration unless added into monthly payments. This is non-refundable & due even if change of mind for enrollment.*

- FULL PAYMENT – Due upon registration

**\*\*Curriculum & Registration Fees are due in full (even with early withdrawal or change of mind in enrollment), regardless if paid up front or added into monthly payments. Tuition is prorated with early withdrawal.**

Preschool – ½ Day	\$3,582
Preschool – Full Day	\$4,425
Kindergarten-5 <sup>th</sup> Grade	\$4,533
6 <sup>th</sup> -8 <sup>th</sup> Grade	\$4,938
9 <sup>th</sup> -12 <sup>th</sup> Grade	\$5,345

Multiple student discounts apply (15% - 2<sup>nd</sup> student; 20% - 3<sup>rd</sup> student, etc. – order in younger student receiving higher discount)

Only one discount applied (except for full payment).
