Tuition Payment Options – 2025-26

Tuition is an annual fee. For your convenience, we offer several payment options. You must make your selection at the time of enrollment. Monthly payments and discounts are rounded up to the next dollar amount.

YOU WILL NOT RECEIVE A MONTHLY INVOICE

TUITION IS DUE THE 1ST DAY OF EACH MONTH

Once you have made your selection, it will apply for the entire school year and cannot be changed at anytime during the year. If we do not receive your first payment on time according to the plan you choose, you will automatically be placed on the 9 month plan.
