**1. Purpose**

This Agreement is for professional whelping and neonatal care services. The Dog Owner remains the sole owner of the Dam and all puppies at all times.

**2. Term of Care**

Care shall begin on \_\_\_\_\_ and end on \_\_\_\_\_. Services include pre-whelp monitoring, labor supervision, whelping assistance, neonatal care, and puppy care until \_\_\_\_ weeks of age.

**3. Ownership of Litter**

The Dog Owner retains 100% ownership of the Dam and all puppies. Nothing in this Agreement transfers ownership or breeding rights to Outlash Bullies.

**4. Scope of Services**

Outlash Bullies will provide 24/7 labor supervision, whelping assistance when medically appropriate, neonatal resuscitation, monitoring of nursing and weight, bottle or tube feeding if required, climate-controlled environment, and daily health observations. This is not veterinary care.

**5. Veterinary Authorization**

The Dog Owner authorizes Outlash Bullies to seek emergency veterinary care if life is at risk. All veterinary decisions prioritize the life of the Dam first. All veterinary expenses are the sole responsibility of the Dog Owner.

**6. Fees**

Service Fee: \$\_\_\_\_\_. Deposit: \$\_\_\_\_\_. Balance due at whelping. All fees are non-refundable once care begins. Additional charges may apply for emergency whelping, after-hours labor, tube feeding, and intensive care puppies.

**7. Expenses**

The Dog Owner is responsible for all prenatal care, progesterone testing, C-section costs, emergency veterinary care, medications, and supplements.

**8. Risk Acknowledgment**

Breeding and whelping involve inherent risks including stillbirth, neonatal death, emergency surgery, and loss of the Dam.

**9. Mortality & Complications**

No guarantees are made regarding litter size, survival rate, natural delivery, or health outcomes. Natural losses are not the responsibility of Outlash Bullies.

**10. Abandonment**

Failure to retrieve the Dam and litter within \_\_\_\_ days of notice will result in boarding fees of \$\_\_\_\_ per day and may be considered abandonment under Pennsylvania law.

**11. Indemnification**

The Dog Owner agrees to indemnify and hold harmless Outlash Bullies from all claims arising from genetic defects, breeding outcomes, natural illness or death, or misrepresentation of health history.

**12. Liability Waiver & Release**

The Dog Owner releases Outlash Bullies from all claims arising from injury or death of the Dam or puppies due to natural causes or complications unless gross negligence is proven.

**13. Limitation of Liability**

Outlash Bullies is not liable for acts of God, natural causes, or veterinary outcomes beyond reasonable control.

**14. No Guarantees**

No guarantees are made regarding litter size, survival, delivery method, or health outcomes.

**15. Emergency Veterinary Authorization**

The Dog Owner authorizes Outlash Bullies to approve emergency diagnostics, medication, surgery including C-section, anesthesia, and hospitalization when immediate treatment is required to preserve life.

**16. Financial Responsibility**

The Dog Owner is solely responsible for all veterinary expenses incurred.

**17. Treatment Priority**

In any emergency, the life of the Dam shall be prioritized over the puppies.

**18. Governing Law**

This Agreement shall be governed by the laws of the Commonwealth of Pennsylvania.

**19. Entire Agreement**

This document represents the entire agreement between the Parties. All modifications must be in writing and signed by both Parties.
