RE: GOVERNMENT SCHOLARSHIP PROGRAMME

This serves to inform you that the Government of Dominica will be responsible for the payment of tuition on your behalf for the academic year 2017/2018 in the amount of US\$9,260.00 to pursue a [REDACTED]

The tenure of the award is for a period of four (4) years commencing September 2017 and is granted on the following conditions:-

- a) That you undertake to abide by the conditions of the Midwestern State University Authorities and conditions stated herein.
- b) That you agree to observe the rules of the Institution as they relate to the conduct and entitlement of students.
- c) That you enter into a bond agreement in the value of **US\$37,040.00**, which represents the approximate cost of the award, to serve the State of Dominica on completion of the programme of study, for a period of **four (4) years** or expiration of the award whichever is earlier.
- d) That you submit annual progress reports to the Government Agency responsible for the administration of scholarship awards (The Human Resource Development Unit, Ministry of Education and Human Resource Development).
- e) That you maintain a 3.0 Grade Point Average (GPA). Should you fail to maintain the said GPA, a first warning will be issued and if consequently repeat then scholarship will be withdrawn and you would be required to meet your tuition to complete your programme.
- f) Should you require an extension of your programme for unsatisfactory reasons, the scholarship will be withdrawn. Should you choose to continue your study programme you will be required to undertake ALL costs associated with the extension.
- g) That you are not allowed to change your approved area of study without the expressed approval of the Government of Dominica and the Midwestern State University.
