

# **Pastor Munye Mtata's Report**

#### Introduction

One of the beatitudes that Jesus mentions in his sermon on the mount is, "Blessed are those who hunger and thirst for righteousness, for they will be filled" (Matthew 5:6). It is true that deep in our hearts we hunger for something; we thirst for something that can give us satisfaction. Sometimes we expend our energies and creativity pursuing things or relationships that only give us momentary satisfaction. But the hunger and thirst that is directed to just relationships between us and God and between us and people around us, is the hunger and thirst that leads to eternal satisfaction. May this be our pursuit this year.

The year 2019 gave us inspiring experiences and motivation for the future. This report will give an overview of the life and ministry of our congregation in 2019, hoping to be inspired for 2020 as we continue in the knowledge of our Lord, growing in our faith and showing Christ' love to our world.

#### 2019 Overview

Many thanks to Rev Dr. Harley and Ami Johnson for years of faithful ministry to Good Shepherd Lutheran Church. On June 30<sup>th</sup>, Pastor Harley winded up his official pastoral ministry, and we have missed him dearly since then. We continue to pray for him and family as they take their time into the new life of retirement.

Much appreciation goes to the Congregational Management Team (CMT), the council that oversees the day-to-day running of the congregation, for their invaluable commitment to this ministry. The many meetings that they held throughout the year to make sure that the ministry of our Congregation continues as a success story, cannot go without notice. It is not only their availability, but the quality of discussions they had as children of God was inspiring, thanks to the chairperson, Mr. Nathaniel Gibson, with his phenomenal skills in steering discussions towards constructive ends.

Special thanks go to Mrs. Angela Friggstad who has been outstanding in providing top notch administration on behalf of the CMT.

Throughout the year, we continued to witness the commitment and zeal of the different ministry participants at different levels such as the Learning Ministry (Sunday School, Confirmation, Youth, and Adult Education) the Service Ministry (CLWR, Food Bank, LuMinHos etc.) the Witnessing Ministry (Refugee Comm/Nest, Diversity and Inclusion), Support Ministry (Stewardship, Fundraising etc.) and Worship Ministry (Music, A/V Tech, Altar Guild etc.). Given the newness of this structure of our congregation, by the end of 2019 not all ministries were as fully functional as had been hoped. Our desire is that we have more of our members availing themselves to participate in such ministries as Witnessing, Worship and Learning.

The specific details of each ministry are provided in the specific reports, but it is with joy to report that we have taken baby steps in reviving the youth ministry outside the confirmation programme. This ministry is meant to address youth issues from a Christian point of view so that our young people are not carried away by any wind of doctrine that professes to offer something better than their faith. It is my hope that parents with youth aged between 13 and 19 will encourage their children to take part in this programme. Furthermore, we give particular recognition to Mrs. Anna Scott for her invaluable contribution to the music ministry that gives vibrance to our worship.

The last point of recognition is the consistent ministry of the congregation members to the outside world. Sustained provisions to the Food Bank have been noted throughout the year, unwavering support to the ministry of the Canadian Lutheran World Relief (CLWR) has also been noted. We are grateful that through these contributions, members have been witnesses of the love of Christ to the World. More creative ways to minister in this regard will be sought as we grow in faith.



### **Conclusion**

As I conclude this report, may I suggest just two of the opportunities that I have noted for ministry within and outside the congregation in the new year. First, our congregation is blessed with a number of young families who love their God, but who may be tied down by the busyness of parenting. A Parents' night out programme with childcare at our congregation is probably what some of these parents may need, as suggested in previous reports. Second, we are also blessed with musicians of note. In witnessing to the world, we may do well to provide an outreach Christian musical concert in this city and invite more people to our church family. I believe we can, as St Paul would say, "...I can do all things through Him who strengthens me." May this be so for us as a church family moving forward, as we hunger and thirst for right relationships.



# **Learning Ministry**

# **Purpose of the Learning Ministry Team:**

**Constitution:** This congregation shall develop an educational program designed to assist persons to grow in grace and faith and in the knowledge of the Scriptures and the Lutheran Confessions for service and witness in the world. To this end, it shall provide learning opportunities with appropriate curriculum, shall recruit, equip and support educational leaders, and shall ensure that adequate study undergirds all functions of the congregation.

# **Sunday School**

Sunday School kicked off with our Superhero them this year. With music, pictures, and treats, we started our year off with 25 registrations. We currently have 15 children from Pre-K to Grade 6 joining us in the Education Wing each Sunday. Our initiatives this year were as follows:



 To create conversation between the children and their families following the service each Sunday. We are still invested in the Sparks program, however, following Sparks Lectionary this year has allowed the children to focus on the Gospel teaching that the sermon is based on, thus <u>bridging</u> what is learned and promoting discussions between the children and families.



- To create a station for children who may not be interested in participating in the back during our group lessons. Those children still attending church are able to take a bulletin for their age group from the station and work through activities geared to the teaching of the Gospel. This was a wonderful initiative created by Ruth Eliason and supported by the team.
- To provide weekly offering from the children to help support the needs of the **NEST** program.

Our Christmas pageant was designed to incorporate all the ages and to allow them to participate separately; focusing each grade on a theme of Advent. A big thanks to our leaders who lead the independent contributions, played the music and those who filled in wherever they were needed.



We currently operate with ten Sunday School team members who lead and teach as well. Our Sunday School presence is active and vibrant, however, the need for teachers is always welcomed. We continue to pray that we can provide the curriculum for our children that they may **know, grow, and show** the love of Jesus!

# **Lutheran Anglican Women's Retreat**

"We Journey Together"

"We Journey Together" was the theme of the second annual Lutheran Anglican Women's (LAW) Retreat held on Friday, Oct.18 and Saturday, Oct.19, 2019 at St. John's Anglican Cathedral, Saskatoon. Our Retreat Facilitator was The Rev. Jessica Latshaw and 34 women attended.

Friday evening Lutheran and Anglican women gathered for a time of fun and camaraderie and orientation to the Saturday schedule. We ended the evening with the Holden Evening Prayer Service led and sung by The Rev. Marilyn Fowlie-Neufeld.

Saturday morning saw us renewing our baptismal vows in the Cathedral. We then had a group discussion of six case studies about "others in our community", street people and those on the margin of society. An Art Project required participants to respond either to selected scripture or to one of the several case studies; the participants' response included both a visual

representation and written response and was designed to open our hearts and minds to the representatives from the social services.

A delicious noon meal and refreshment breaks were provided by the St. John's Cathedral Parish women.

The afternoon session consisted of presentations from four Saskatoon Service Organizations: The Salvation Army, The Light House, Interval House and The Open Door Society, with opportunity for questions and discussion. This was followed by a meditative walk in small groups in the Cathedral, responding to scripture and related questions along the way. The day concluded with Holy Eucharist and after the service the participants picked up a prepared Renewal of Baptism Certificate.

# **Witnessing Ministry**

#### **Purpose of the Witnessing Ministry Team:**

There are positive indications that two families may arrive in Saskatoon in 2020. One will be a family reunification of two sisters. The first woman and her son arrived in Saskatoon in 2014. In 2016 we submitted the application for the second Iraqi sister and her son, who are presently living in Dubai, to come to Saskatoon. The second application was submitted in 2018 for a Sudanese family who are

presently living in Israel. This is a family of four, consisting of parents and their two young daughters. If you have interest in helping settle any of our families, please contact myself.

Sunday, July 26, 2020 is the date set for our NEST Garden Tour. This is our major fundraiser and is a lovely way to spend a Sunday afternoon, viewing some of the most beautiful gardens in our city.

Making a banner with the word "Welcome" in many languages
Setting the first focus on Indigenous people we presented "Reserve 107" followed by questions for discussion. Other ELCIC churches were invited as well.

# **Service Ministry**

# **Purpose of the Service Ministry Team**

**Constitution:** Service – This congregation shall live by faith active in love. It shall motivate, equip and support its members to: minister in daily life; participate as members of a caring community; serve as Christians in all the institutions and structures of the society of which they are a part; and promote justice and reconciliation, meet human needs and alleviate suffering, both individually and corporately. In these efforts, this congregation shall cooperate with the synod and the ELCIC, other Christian churches, faith communities and groups in society. It shall make certain that all its functions strengthen the motivation and ability for service.

Good Shepherd is involved in several community projects and church related ministries. Following is a summary of some of the initiatives the members are encouraged to participate in.

**Saskatoon Food Bank** – a food barrel is in the entrance of the church that members can put donations of non-perishable food in. We could use a coordinator for this project who would contact the Food Bank to pick up the barrel when it is full and to let members know what is most urgently needed. If you would be willing to take on this role, please let Angela, church administrator, know.

**Lighthouse** – Members can contact the Lighthouse directly to sign-up for volunteer activities. A Rubbermaid tub is in the fellowship area where donations can be left for the Lighthouse. Items such as gently used clothing, jackets, toques, mitts, socks, hygiene projects etc. can always be used. A coordinator is also needed to be the liaison between the church and the Lighthouse. Let Angela know if you are willing to serve in that role.

**Pride House/Out Saskatoon** – have also been supported by Good Shepherd. The LGBT community is welcome at Good Shepherd. Again, we could use a coordinator to keep Good Shepherd informed of their needs.

Canadian Lutheran World Relief (CLWR) — early in 2019 Pastor Carla Blakely the Community Relations Coordinator for CLWR participated in a service at Good Shepherd. This fall funds were raised to develop 7 gardens in Uganda.

Lutheran Ministry in Hospitals of Saskatoon (LuMinHoS) – members of Good Shepherd have been very supportive of LuMinHoS by attending their fundraising events and volunteering to assist the agency as needed. Chaplain Ron Bestvater has resigned from LuMinHoS to accept the call to Zion. LuMinHoS is currently in the process of calling a new Chaplain. An interim Chaplain will be in place until a new Chaplain accepts the Call. Joan Meyer is the volunteer administrative assistant for LuMinHoS. Please contact her if you want to become involved in this vital ministry.

**Sask Synod** – the Synod annual report will be attached following the Service Report (if it arrives in time).

**LutherCare Communities** – LutherCare is celebrating its 65<sup>th</sup> Anniversary this year. This organization operates 6 Senior Housing Developments – 4 in Saskatoon that also have Intermediate Care Homes within them, 1 in Estevan and 1 in Outlook; 10 Group Homes in Saskatoon; a Home Support Program in Saskatoon; and 30 townhouse units for Family Housing. Members from Good Shepherd assist with music programs in these homes and several members attend the various fund-raising events held throughout the year. Karen Harilstad and Beverly Pavelich serve on the LutherCare Board of Directors.

#### Saskatoon ELCIC 7 Churches

The seven ELCIC churches in Saskatoon—Augustana, Good Shepherd, King of Glory, Redeemer, Resurrection, Trinity, and Zion—formed a group to enhance collaboration and communication amongst the congregations.

We held a brain storming session that resulted in four points of focus:

- worship,
- communication,
- administration,
- social justice & outreach

We prepared a power point presentation which was reviewed at all seven churches. Question and answer sessions followed with positive feedback.

#### Accomplishments so far:

Worship committee is looking at offering VBS in an area of Saskatoon not currently served by a Lutheran Church. We held one meeting in November and another in January to start the planning process with target of offering one week of VBS in the summer 2021.

The communication committee is working on developing a website that will contain information on all seven churches, a space to share information on special services and events, as well as provide links to each congregation's and other Lutheran affiliates websites. We want the design of it to be easy to use. We are working on applying for funding from Synod Mission in Ministry. We will be looking for someone to do ongoing maintenance on the site once it is up and running. In the meantime, congregations are encouraged to share information through the administrative assistants' group email.

# **Support Ministry**

#### **Stewardship Items:**

- Two fund-raising events were held to help raise funds for much needed improvements in the church – paint and flooring.
- A major appeal was made during the last quarter of the year to ask for funds to meet financial requirements by year end.
- Thank you for all those who help with collecting and counting the offering; Marty for doing the bookkeeping for the church and Angela for the office administration and posting the donor records.

#### **Building & Property Items:**

#### Inside the church:

- The telephone system was replaced as the old one no longer had technical support provided
- The toilets had replacement parts installed rather than replacing them
- A good used stove was donated and installed in the kitchen
- Door sweeps were replaced, fire extinguishers checked, the replacement of the balcony railing was put on hold, a new doorbell and chime were installed
- The Pastor's office was cleaned out and repainted
- A major cleaning bee with over 30 members helping was held at the church in September with many cupboards, closets and offices being de-junked; windows being cleaned; chairs washed; etc.
- Following the annual check-up on the furnaces it was determined two of them had come to the end of their reliable working life and needed to be replaced. Fortunately, a donor covered the cost of their replacement.
- Handrails were installed going up to the chancel area

#### Outside the church:

- Broken posts in the parking lot were replaced
- Siding was put on the old storage shed
- The Diabetics bin was moved near the sidewalk on the south parking lot
- The junk pile was removed from behind the storage shed
- The old water-line manifold was removed
- The ruts in the lawn caused by SaskPower were repaired and compensation received
- Flower beds and pots were planted and maintained by members throughout the summer
- Shrubs are trimmed and the lawn cut by volunteers throughout the summer



#### **Caretakers**

Kara and Chris Tucker continue to be the caretakers for the church. In addition to regular weekly tasks they have also shampooed the carpets; stripped the old wax from the tiles and waxed them till they shone; and sanitized the toys in the nursery. Their meticulous care of our church makes it a welcoming place to come to.

# Saskatchewan Synod Insert for 2019 Congregational Annual Reports

Year-end letter from Bishop Sid Haugen

As you gather this winter for your annual meeting, with the reports from rostered leaders, council, treasurer and committees in front of you, let me share highlights from the work of our synod framed around our 2014-2019 Strategic Plan: "Strengthening Faith Communities for Service." The three focal areas for the synod in the plan were: Build leadership capacity; Operate as one team; Practice love and service.

#### **Strengthening Faith Communities for Service**

**Build leadership capacity:** No one congregation could train its own pastors and diaconal ministers. Building leadership capacity is perhaps the Synod's most important work at this time in the Western world. We are experiencing a significant shortage of available pastors particularly in our town and country parishes, and to a lesser extent in our urban parishes. At the same time, we have parishes who no longer have the financial capacity to support a pastor if one were available. These questions are in the middle of much the work of synod office. In this area I would highlight work with Lutheran Theological Seminary, Wide Area Ministries, and Authorized Lay Ministry.

Lutheran Theological Seminary: We continue to need to form pastors and diaconal ministers for our faith communities. The Synod supports our major partner in this work, Lutheran Theological Seminary in Saskatoon.

It has been a challenging and creative year with our Seminary partner. I would like to spend some time here to keep you in the loop about significant changes at the seminary. As I reported last year to the congregations, the Board of Governors of LTS has been working with President Harrison to reimagine the seminary in the world of the 21<sup>st</sup> century. Over the last few years, the Seminary has engaged in conversations that are becoming familiar to our town and country parishes. Can we live more efficiently in a large building built for another era? Can we share our facility? Can we work with partners to more creatively be the church in the 21st century? After conversations with Luther College Regina, and with Saskatchewan Synod's Campus Ministry in Saskatoon another door opened unexpectedly for LTS. St. Andrew's College in Saskatoon (a seminary of the United Church of Canada) quite suddenly discovered that they had significant rental space available in 2020. As they were aware that LTS was in the process of looking for a different working space, St. Andrew's approached the Board of Governors through President Harrison. The big and I think hopeful news is that the Board of Governors voted that LTS would move in the summer of 2020 into St Andrew's, together with Emmanuel and St. Chad's (the Anglican Seminary); to form what we hope will be an arrangement that will be both cost-effective and will generate more significant sharing in our Saskatoon Theological Union. It is a hard move to leave behind the beautiful and historic 55,000 square foot LTS campus. On the other hand, working more efficiently, more humbly, more cooperatively, more inclusively seems to be the way that our church moves forward in the 21st century.

Wide Area Ministry: I have been working with the bishop's assistants to gather congregational leaders in several areas for facilitated conversations about wide area ministry. In one particular area, we have 10 congregations who have sent representatives for the last two years to meet for Bible study and prayer and for conversation about their particular gifts and challenges in ministry. What is the clearest learning from our conversations is that there is no 'easy answer'. But it also seems clear that when we walk together and pray together, the Spirit speaks with us of a hopeful future.

Authorized Lay Ministry: One concern about developing a wide area ministry served by a rostered minister is that the pastor is 'spread too thin' and that the cost of travel for congregations can be significant. The Synod has been working on a way of addressing ministry needs through a form of lay leadership based on the 2015 ELCIC Policy for Authorized Lay ministry. Over the past year, we developed a 'pilot project' with an ordained pastor mentoring an Authorized Lay Minister in the Quad parish—just north of Regina. The one-year pilot was presented and approved, as per policy, by the ELCIC Conference of Bishops. The pilot project was completed in December of 2019. After receiving our report on the pilot, the Conference of Bishops approved the site on an ongoing basis in January, 2020. Though not all Authorized Lay Ministers would include the administration of Holy Communion, our initial site does include this dimension. This is the first approved site of Authorized Lay Ministry nation-wide. It is an encouraging beginning.

**Operate as one team:** On a very basic level, synod acts as a 'cooperative' of congregations and ministries. Congregations provide benevolence to the synod so that the whole body is offered support. Congregations give to the synod so that their sisters and brothers across the synod have support when it is time to call a pastor or when it is time to handle a congregational issue or even

when it time to deal with the difficult work of church closure. In this area I would highlight our rebuilt Synod Communication Network, and a comment on Synod Office relocation.

Synod Communication Network: At synod office this year we focused considerable energy on improving our communication network. With congregational leadership often changing, we found that frequently synod messages were not being received. Our office decided we could no longer accurately keep several lists of changing congregational leaders (chairpersons, treasurers etc.) but would rather set out to secure a single stable email address as the congregation's official contact who would then distribute synod 'mail' to the congregational leadership (not so different from the days of passing on the letters and packages received through Canada Post!). The results are encouraging thus far, with about 200 contacts in our targeted distribution lists for rostered ministers, congregational leadership, and synod leadership. Please contact synod office if your congregation does not have an official email contact for synod office communication. At the same time, synod office began to deliver mail of more general interest beyond the congregational leaders through an email service called 'mailchimp'. The service allows anyone interested in general synodical news and events to subscribe (or unsubscribe) to Synod News bulletins through the Synod News link on the Synod website. That wide list has grown to about 700 recipients.

Synod Office Move: With the seminary's departure from 114 Seminary Crescent, our synod office will need to relocate in the summer of 2020. Staff have been exploring several interesting possibilities across Saskatoon for a potential new Synod office site.

**Practice love and service:** The Synod also sets out to inspire congregations and ministries in practicing love and service. Bishop's visits, visits of the Assistants to the Bishop, the Sasksynod insert in the *Canada Lutheran*, the synod website (<a href="www.sasksynod.ca">www.sasksynod.ca</a>), broad email from synod office, National and Synodical conventions, CLAY (our national youth gathering that takes place every two years)— all set out to widen our vision of the church beyond local boundaries and to inspire our people to live out the gospel in our own time and place.

# Two things to share with you as 2020 opens.

I would share with you a broad sketch of the synod's financial work and then close with two words.

A sketch of synod financial work: The synod is generally financed by the voluntary 'benevolence' of our congregations and ministries. From that benevolence Synod supports our key partners: 20% of that benevolence to our National Church and 15% of benevolence to our Lutheran Theological Seminary. The remainder is used directly within our synod. Staffing at synod remains quite lean: our administrative team in Saskatoon consists of a ¾ time office manager, a ½ time executive assistant, and a ¼ time finance manager; our pastoral team on the road consists of two ¼ time Assistants to the Bishop. This staffing level supports relationships with 115 congregations and with various ministries in the synod. I am very pleased with the energy and the faithfulness of this group of people. Congregational benevolence also supports the work of synod council, synod committees and provides a synod office for the administration of the synod.

All of this is from congregational benevolence given voluntarily from across the synod. One question we receive from time to time at synod office is, "how much should our congregation give to synod office?" The answer is on one level the same as the answer when the plate is passed by you on a Sunday morning: "It's up to you." How has God blessed you? What can you 'pay forward'? On another level a congregation giving to the synod is different. If giving to the congregation is about giving beyond 'me' to care for the community around me; a congregation giving to the synod is to give beyond 'us', beyond the people we see around us where we live to those who are not visible to us on a Sunday morning: your sisters and brothers across the synod in 115 little, middle, and big congregations; the ministries we work with in the synod, the Seminary, and our National church. So I would ask you as you gather to give beyond your own 'us'. Decide whether that is a percentage of your general offering, or a set amount given monthly or periodically. Then, prayerfully commit to the whole synod what God has given you the ability and the will to give.

Two words: Most importantly, I want to thank you. Thank you first of all for your support and commitment to your local congregation. That truly is where the 'rubber hits the road' for our synod—that is where the Gospel is proclaimed in word and sacrament and in acts of care and compassion. I want to thank you as well for your support of the synod over the past year: for participating or for taking on a role in the ELCIC convention in Regina in the summer of 2019, for serving on synod council or a synod committee or on a bishop's ministry team; and for your financial contributions to the synod.

And most importantly, I want to thank you for your continued prayers for me as your bishop, and for your whole synod staff. These are challenging times to be church. For all of us.
