

as per Annexure – II) that PAN India sales data financial year (FY) wise in weight (metric tonnes) of the selected electrical and electronic equipment (EEE) will be submitted in 60 days of grant of registration on the portal failing which registration will be revoked. (Stamp Paper should be from the State where corporate office is located)


