Dealer Buy-In Requirement

INITIAL HERE_____ A minimum opening order of \$2,000.00 is required upon approval of your dealer. Please email a list of items you would like to purchase if unsure we can go over all options and help guide you on what would be good sellers.

How the Buy-In Works: FIRST ORDER MUST BE DONE VIA PHONE 330-806-0728

- Your first order must total a minimum of \$2,000.00.
- Dealer pricing and discounts will be applied to your first order.
- Once your first order is placed, your dealer account will be approved and activated.
- You will then be set up with access to the RNG Performance dealer website and dealer

pricing portal.

Dealer Pricing & Sales Policy

To remain in good standing, all RNG Performance dealers and resellers must advertise and sell RNG products at or above the current MRP (Minimum Retail Price).

Violation of this pricing policy may result in suspension or permanent revocation of dealer status.

Every 6 months, dealer accounts will be reviewed and evaluated based on total sales volume and dealer activity.

Shipping & Freight Policy

- Freight charges must be prepaid.
- RNG Performance will make every effort to ship orders the same day if placed before 12:00 PM EST.
- Once an order has been billed, it cannot be changed, modified, or added to.
- Additional items will require a separate order to be placed.

BULK ORDERS done VIA the website may have extra shipping charges we will then call you to pay the extra shipping.

Backorder Policy

- All backordered items will automatically ship once available.

Clutch kits may be out of stock and can take up to 10 weeks to come available.

- If an order contains both in-stock and backordered items, the entire order will ship once all items are available. Clutch kits can sometimes not be in stock due to high volumes of orders.
- Dealers may request split shipments by calling RNG Performance and paying additional shipping charges.

Merchandise Return Policy

A Return Authorization Number (RA#) — also known as your ORDER# — is required for all return requests.

- NOT ALL RETURNS ARE ACCEPTED.

- Returns for any reason other than defective merchandise may be subject to a 25%

cancellation/restocking fee. Out of stock orders if canceled will have a 25% Cancellation charge unless per our policy 90 days has passed then there will be no charge.

- Returned products must be in original packaging.
- The ORDER# must be clearly marked on the outside of the package.
- Approved returns must be shipped within 10 days of authorization approval.
- All discontinued, closeout, and clearance items are FINAL SALE.

Damaged or Short Shipment Policy

RNG Performance must be notified within 7 days of invoice date regarding damaged shipments, missing items, or short shipments.
