Tents

Electricity will be provided.

Vendors will be responsible for their own lights, extension cords and power strips.

Sales People at the Tents

Two weekend general admittance tickets will be available to each vendor. \$40.00 – discounted - tickets are available for three additional staff members. People knowledgeable of the items for sale must be present in vendor tents at all times during the festival. No one under 21 shall be allowed to attend to the vendor space.

- All vendors will display their products in a clean and safe manner.
- All vendors should bring their own trash receptacles. At the close of the show, vendors will clean their immediate area and remove trash to the on-site dumpsters.
- Vendors should operate their business in a professional manner at all times.
- All vendors will be responsible for the actions of their employees and/or agents.
- Possession of weapons and/or firearms and/or fireworks; thievery, gambling, or disorderly conduct by a vendor or their staff will result in immediate removal from the event.
