General Rules and Regulations for The Event

(You must acknowledge that you have read, understand and accept the rules and regulations for the event by signing this copy and returning it with your application. A signed copy will be returned to you upon your request, after acceptance to the event).

Allotted Space

All food vendors will be given an allotted space that will be marked and numbered. All your vehicles, equipment, tents and staff cars are to be within this space. Additional parking will be available in vendor parking. If you need additional space, contact the Food Vendor Coordinator prior to the event.

Tents

Vendors are strongly encouraged to obtain a tent or canopy as there is no shade or rain protection on the grass. All tents and canopies must be secured with weights (no cabling) in case of strong gusts of wind.

Tables and Chairs - Food vendors must supply their own tables and chairs. There is a covered dining area in the food court.

Electricity will NOT be provided. Food vendors are responsible for supplying their own electricity, lights, extension cords and power strips. All generators must NOT disturb those surrounding them. 75 dBA or below. If your generator is loud, will be asked to move.

Sales People

Three weekend General Admittance tickets will be available to each vendor. \$25.00 (discounted) tickets are available for three additional staff members. People knowledgeable of the items for sale must be present in the food court at all times during the festival. No one under 21 shall be allowed to attend to the vendor space.

- We prefer food carts or food trucks.
- All vendors will display their products in a clean and safe manner.
- All vendors should bring their own trash receptacles. At the close of the show, vendors will clean their immediate area and remove trash to the on-site dumpsters. (If trash is left behind, you will not be invited back we are serious.)
- Vendors should operate their business in a professional manner at all times.
- All vendors will be responsible for the actions of their employees and/or agents.
- Possession of weapons and/or firearms and/or fireworks; thievery, gambling, or disorderly conduct by a vendor or their staff will result in immediate removal from the event.

Vend at your own risk. It is expected that you will abide by all venue, local and state rules, codes and ordinances.

All vendors are expected to carry their own liability insurance. By signing this form, you acknowledge that Delfire Group, Inc. is not liable for any damage or bodily harm from any negligence that you may cause.
