

LEAGUE23 PERFORMING ARTS COLLECTIVE TERMS OF ENROLMENT

By signing / submitting an enrolment form online, these Terms of Enrolment, the Student and Parent/Guardian agrees to be bound by these Terms of Enrolment, the League23 Performing Arts Collective Policies and Protocols as amended from Sunday 12th November 2023.

1. Upon enrolment you will be charged an enrolment fee per child and this is payable prior to the term commencing (or at time of enrolment if later in the year).
2. Fees are payable per term and are non refundable. Fees are due by the end of the term, the date specified on our Calendar of Events. Upon enrolment you are agreeing to one term of dance and must pay for those classes even if the student is absent. You acknowledge and agree that you are responsible for fees and those fees are to be paid by the end of each school term. If fees are not paid within this time, a late payment administration fee will apply.
3. There are no refunds for missed classes. Students are more than welcome to sit and watch their class if they are unwell enough to dance but well enough to attend. With appropriate notice of absence, Private Lessons will be credited their cost.
4. Class cancellations are sometimes necessary. If class cancellation occurs and make up classes are not available, a credit will be offered for the cost of the cancelled class.
5. You consent to photographs and video footage being taken of your child performing in the concert, class work, dance assessments and/or other activities at the school. These images may be used on League23 Social Media and/or for the purpose of promotional material only.
6. In the event of an emergency – illness or accident, where you cannot be contacted, you give the staff of League23 Performing Arts Collective permission to refer your child to a Doctor, Ambulance or Hospital.
7. Participation in any League23 Performing Arts Collective's activity and use of any recreational facilities involves a risk of accidental injury despite all safety precautions. Having been informed of the activities conducted by League23, you as an individual or as a parent or guardian of the participants named in the enrolment, assume all risks and hazards incidental to the activities, and release from responsibility and agreed to indemnify and hold harmless League23 Performing Arts Collective (its officers, directors, independent contractors, volunteers and all employees) for any illness or injury to your or your children or family members occurring during his/her/your participation in any activity conducted by the school.
8. Students and Parents acknowledge that as a part of dance and effective dance training, students will be at times assisted with skills and body placement by teachers. Teachers are trained to hold and assist dancers effectively and safely.
9. Students will not be permitted to attend other dance schools or receive other tuition from other school while taking class at League23 and without the permission of League23 staff. This is to avoid any and all conflicts of interest between schools that could affect the training of the dancers.
10. Students will be required to purchase and wear a uniform when attending classes, competitions and scheduled League23 events. This is required for purchase after 2-3 weeks of lessons.
11. The director and staff of League23 will remove a parent or child if their actions or intentions do not meet the ethics of the school. League23 is built on support and encouragement and we will ask people to leave if they violate these terms.
12. All League23 students must participate in the end of year concert.
13. League23 will inform all families at the time of costume purchase for the concert. If we do not receive notice that a student is not performing (absent or otherwise from the concert) and at the time purchase a costume for this child, the parent/guardian agrees to pay League23 for the cost of the costume and keep the costume.
14. End of year concert costumes will not be handed out until all fees have been paid. If overdue fees are in question, League23 will not release costumes until either; the fees have been paid or an effective payment plan is in order.

FOUL PLAY

1. Bullying, harassment and intimidation will not be tolerated under any circumstances. Any student or parent found to be bullying or tormenting any other child will receive consequences deemed by League23 up to suspension and expulsion from the school.
2. Any student or parent/guardian found to be negatively speaking, creating a toxic environment, threatening others or similar will not be tolerated. This extends to social media and behaviour at competitions that may deem League23 to be perceived by others negatively. Absolutely no negative comments, language or over-competitive behaviour to dancers, teachers or families from League23 and other studios will be tolerated.
