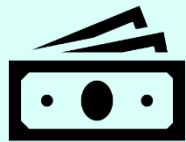

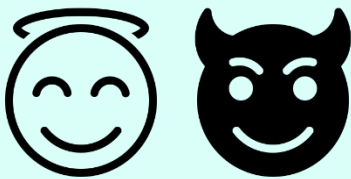

Sec 6, art I of the Wisconsin constitution and the Eighth amendment to the US constitution provide “Excessive bail shall not be required.” Whether the Eighth amendment is directly applicable to this state criminal prosecution or is a specific provision of the Bill of Rights which is incorporated or absorbed as such by the Fourteenth amendment and applicable under the doctrine of due process the result is the same. *Whitty v State*, 34 Wis. 2d 278, 285, 149 N.W.2d 557, 560 (1967)

# WRIT OF CERTIORARI



## **Writ of Certiorari**

Judicial review of a revocation decision may be obtained by writ of certiorari in the county in which you were last convicted of an offense for which you were on supervision. Any action seeking a remedy available by certiorari made on behalf of a prisoner as that term is used in Wis. Stat. §801.02(7) must be commenced within 45 days of the decision to be reviewed.

See Wis. Stat. §893.735. The Petition for writ of certiorari should name the division administrator as the respondent and must be filed with the appropriate court and then served on the Division of Hearings and Appeals at 4822 Madison Yards Way, 5<sup>th</sup> Floor, Madison, Wisconsin 53705-5400.

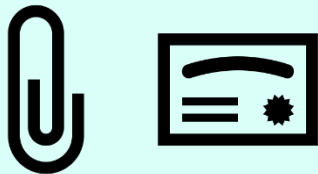

# WRIT OF HABEAS CORPUS



## **Writ of Habeas Corpus**

A writ is actually a court order requiring an agency to do something. For example, we have filed writs to ask the court to order a person to be released from prison for various reasons. We recently had a successful situation where we argued on a writ of habeas corpus that a person was incarcerated wrongfully due to the ineffectiveness of his attorney at a probation revocation hearing.
