1. Our Commitment to Privacy

HH Hills Living Trust (“we,” “our,” or “the Trust”) is a privately held regenerative land and legacy trust based in Olympia, Washington. We honor your time, your peace, and your data. Our goal is to collect only the information needed to operate our website, support our community, and communicate responsibly with people who request to connect with us. We will never sell, rent, or trade your information.

2. Information We Collect

When you visit hhhills.com or our affiliated pages, we may collect the following information:

- Voluntary Information: Name, email address, and message content submitted via forms, to respond to inquiries or investor interest.
- Technical Data: Browser type, device ID, referring URL, and cookies, used only for site performance and security.
- Transaction Data: Payment details if you donate or make a purchase, processed securely through trusted payment providers.
- Community Participation Data: Feedback forms, event registrations, or applications for workshops and programs.

We do not knowingly collect data from children under 13.

3. How We Use Your Information

We use your data only to: respond to your requests; send updates about trust projects, events, or opportunities (if you opt in); process donations or purchases; and maintain site security and functionality. We do not use personal data for behavioral advertising or third-party tracking.

4. Cookies & Analytics

Our site may use privacy-friendly cookies or analytics tools to understand how visitors interact with content. You may disable or manage cookies through your browser settings at any time.

5. Data Storage & Security

All data is stored on secure, U.S.-based servers with encrypted connections (HTTPS/TLS). Access is restricted to authorized trust stewards who require information to operate the site or fulfill requests.

6. Your Rights & Choices

Depending on your location, you may have rights to request access, correction, or deletion of your personal data, and to withdraw consent for communications. To exercise these rights, email contact@hhhills.com with the subject line 'Privacy Request.'

7. Data Sharing & Third Parties

We share data only with trusted service providers (e.g., payment processors, email tools) under confidentiality agreements, or with legal authorities if required to comply with the law. We do not sell or lease data to advertisers or third parties.

8. Data Retention

We retain personal information only for as long as necessary to fulfill the purposes described in this policy or as required by law. When no longer needed, data is securely deleted or anonymized.
